The 2009 Form 5500 for Broadcom Voice & Data, Inc.'s 401(k) Profit Sharing Plan & Trust Plan is being filed late pursuant to the Department of Labor's Delinquent Filer Voluntary Compliance (DFVC) Program.

Broadcom pays Paychex, their payroll company, for its 401k services and administration. Paychex takes care of all recordkeeping and in previous years, prepared the paper Form 5500. With the new efilg and signing requirements through the Department of Labor's EFAST2 website, there was a communication breakdown between the payroll company and the client. As a result of this confusion, the report which was timely prepared on paper, was not properly electronically filed with the Department of Labor through its website. As this late filing was a result of the confusion over the new complex requirements to file the Form 5500, we are requesting an abatement of any penalties assessed under the DFVC program.
