Dear Sirs and Madame,

My client Schmitt Automotive, Inc has a one employer plan where there ~~are~~^{were} two participants, Frank Schmitt and Walter Bach. They had their assets in separate accounts at Ameritrade for many years and then in 2008 we terminated the plan.

The plan termination was an exhaustive process. Many pages were required to answer all the questions and research the proper responses to the questions on the termination. All of the assets in the plan were distributed to Frank Schmitt and Walter Bach on or about June of 2008.

The assets at the end of 2008 were 0 zero.

An IRS letter was received by the client in April asking for the 12/31/08 5500 form. I researched this and found that the IRS and the DOL no longer accept paper forms.

Further that the IRS and the DOL no longer accept prior returns. So Attached are the 2008 forms attached to a 2010 year filing.

The reason for the late filing is that there was some confusion as to the requirements of the final year of the plan. The termination document was not sufficient to finalize the 5500 record.

This filing finalizes the 5500 Plan for Schmitt Automotive Inc.

Please abate any penalties under the reasonable cause guild lines because we filed the termination document with nearly 30 pages of attachments and we thought that it was sufficient to close the 5500 filing.

In addition the complexity of filing the return made it difficult to comply with the filing requirement.



