This is a summary of the annual report for Berner Oil Company, Inc. Profit Sharing Plan and Trust, 59-2137307/001 for 10/01/2010 through 09/30/2011. The annual report has been filed with the Employee Benefits Security Administration, formerly known as the Pension and Welfare Benefits Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

***Basic Financial Statement***

Plan expenses were \$16,290. These expenses included \$8 in administrative expenses, \$16,282 in benefits paid to participants and beneficiaries, and \$0 in other expenses. A total of 13 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan was \$284,077 as of 09/30/2011 compared to \$288,821 as of 10/01/2010. During the plan year the plan experienced an decrease in its net assets of (\$4,744). This decrease includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$11,546, including employer contributions of \$0, employee contributions of \$15,992 and earnings from investments of (\$4,446).
