- The financial executive responsible for managing the company's reporting obligations experienced serious illness resulting in disability leave beginning July 2012 and subsequent death on August 3, 2012.
- The accounting staff member responsible for completing the filing also left the company during July 2012.
- The company's remaining accounting staff (which is quite small) has put forth its best efforts to identify and resolve reporting requirements as quickly after the above mentioned events as possible.

We have every intention of complying with reporting and disclosure rules. We believe that the late filing of this Form 5500 is the result of reasonable cause, not willful neglect. We do not anticipate the same issues in the future and the filings in the future will be timely. We would ask for abatement of the purposed late filing penalty.
