

### ***Disclaimer of Opinion***

Because of the significance of the matter described in the *Basis for Disclaimer of Opinion* paragraph, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion. Accordingly, we do not express an opinion on these financial statements.

### ***Other Matter***

The Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2012, is required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA and is presented for the purpose of additional analysis and is not a required part of the financial statements. **Note 1 - Plan Description**

The following description of the Zetron Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan that was established for the benefit of substantially all U.S. based employees of Zetron, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Company is the Plan's sponsor and serves as plan administrator.

**Eligibility** - Employees of the Company are eligible to participate in the Plan upon reaching 21 years of age.

**Contributions** - Employees may contribute up to 60% of their eligible compensation. The Company makes matching contributions of 50% of participant contributions, up to the first 10% of the participant's compensation that is contributed. The Company may make additional discretionary contributions. There were no discretionary contributions during the year ended December 31, 2012. The Company's matching contributions are remitted to the Plan on a pay-period basis.

**Participant Accounts** - Each participant account is credited with the participant's contributions, Company matching contributions, Company discretionary contributions, and an allocation of earnings. Allocations of earnings are based on participant account balances.

**Notes Receivable from Participants** - Participants may borrow up to 50% of the vested portion of their account balance (\$1,000 minimum, \$50,000 maximum). Participants are allowed to have one loan outstanding at a time. Loan terms range from one to five years, or up to ten years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate, as determined by the plan administrator. Principal and interest payments are made ratably through payroll deductions. As of December 31, 2012, outstanding loans bore interest between 4.25% and 7.75% with various maturities through November 2017.

**Vesting** - Participants are fully vested in their salary deferrals plus actual earnings thereon. Vesting in the Company's contributions and earnings thereon is based on years of service with increases in increments of 20% per year resulting in full vesting after five years. In the event of death, total and permanent disability, or retirement at the normal retirement age of 65, the Company's contributions will be fully vested immediately.

**Payment of Benefits** - Benefits are payable at retirement, death, total and permanent disability, or upon termination of employment. Upon termination of service, a participant whose vested account balance is \$5,000 or less will be subject to automatic distribution. A participant whose vested account balance is more than \$5,000 may elect to receive benefits under one of the following options: a lump-sum amount equal to the value of the participant's vested account balance, or the participant may elect to defer receipt of the distribution to a date no later than April 1 following the calendar year in which the participant attains the age of 70½ years.

**Forfeitures** - Forfeitures of non-vested contributions are used to pay administrative expenses and to reduce future employer contributions. As of December 31, 2012 and 2011, forfeited nonvested accounts totaled \$4 and \$1,669, respectively. During the year ended December 31, 2012, forfeitures totaling \$26,771 were used to reduce employer contributions.

**Plan Termination** - Although it has not expressed any intention to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time. If the Plan is terminated, participant account balances become fully vested.

**Note 2 - Summary of Significant Accounting Policies**

**Basis of Reporting** - The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America, using the accrual method of accounting.

**Use of Estimates** - The preparation of the financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

**Investment Valuation** - Investments are stated at fair value as certified by Fidelity Management Trust Company (the Trustee). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. Authoritative guidance requires the statements of net assets available for benefits to present the fair value of the investments, as well as the adjustment from fair value to contract value for fully benefit-responsive investment contracts. The statement of changes in net assets available for benefits is prepared on a contract value basis.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

**Notes Receivable from Participants** - Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are recorded as distributions based on the terms of the Plan document.

**Income Recognition** - Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments consists of both the realized gains or losses and unrealized appreciation and depreciation of those investments.

**Payment of Benefits** - Benefits are recorded when paid.

**Administrative Expenses** - The Company pays a substantial portion of the administrative costs of the Plan.

**Subsequent Events** - The Plan has evaluated subsequent events through July 26, 2013, which is the date the financial statements were available to be issued.

**Note 3 - Tax Status**

The Plan document is a non-standardized prototype plan that received a favorable opinion letter from the Internal Revenue Service dated March 31, 2008, which stated that the prototype plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

In accordance with guidance on accounting for uncertainty in income taxes, management evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2009.

**Note 5 - Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy for financial assets and financial liabilities are described as follows:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

**Level 2** Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**Note 5 - Fair Value Measurements (Continued)**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2012 and 2011.

*Registered investment companies (mutual funds):* Shares of mutual funds are valued at the net asset value (NAV) of shares held by the Plan at the closing price reported on the active market on which the individual securities are traded.

*Collective trust:* Units held in the collective trust are valued using the NAV of the fund. The NAV of a collective trust fund is calculated based on a compilation of primarily observable market information. The number of units of the fund that are outstanding on the calculation date is derived from observable purchase and redemption activity in the fund.

The Plan has investments in the Fidelity Managed Income Portfolio which is a collective trust fund designed to provide preservation of capital and returns that are consistent regardless of stock and bond market volatility. The collective trust seeks to earn a high level of income consistent with those objectives. The fund holds guaranteed investment contracts which typically have a fixed maturity. Each contract contains a provision that the issuer will, if required, repay principal at the stated contract value for the purpose of paying benefit payments (fully benefit-responsive).

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks.
