This filing is being submitted with the following remarks:

1. Plan Sponsor has a self-insured health plan under a cafeteria plan arrangement with an ASO agreement in place. According to current instructions, welfare plans are not required to file schedule A for health insurance under an ASO stop-loss arrangement nor is there a requirement for a schedule C under a cafeteria arrangement. Commissions paid on the account are part of the schedule recently received for the Stop-Loss coverage from Zurich American Insurance Company which is exempt from current filing requirements;
2. Additionally, the Plan Sponsor is anticipating a delinquent filing for the 2011 plan year for which they are attempting to secure Schedule A documentation before submitting. There has been a change of Agent of Record in 2012. Only partial coverage is documented currently from March 1, 2012 thru June 30, 2012 at this point. An attempt is being made to retrieve the remainder of the plan year coverage from July 2011 thru February 2012 to complete the filing;
3. Last known 5500 filing for this welfare program was recorded in the 2010 plan year filing.
