I made a mistake by thinking that a 5500 return was not required to be filed for this plan year due to the fact that no contributions were made that year and the two employees that were still in the plan were 100% vested in their accounts with the plan, there were no plan liabilities.

The plan is administered by JP Hancock and the plan assets were all invested in eligible assets

The plan will be terminated effective 1-1-2015 and the plan assets will be distributed to the two participants and rolled over into an IRA.

I have filed the delinquent return on the DOL website through IFILE.
I request that you please forgive any penalties for late filing due to my misinterpretation of the filing requirement.
