1. Health plan is self-insured under an ASO stop-loss arrangement and financed by cafeteria plan deductions, and, therefore, administrative expenses of these plans are exempt from ERISA filing requirements per 29 CFR 2520.104-44 and DOL TR 92-01;
2. Ameritas Schedule A now includes vision coverage for 2013, whereas last year, it only had dental coverage for 2012;
3. Plan Sponsor does have a Wrap plan in place to substantiate consolidating all coverages into one single filing which was incepted as of July 1, 2008 and later restated as of January 1, 2015. Consequently, the Plan Sponsor has incurred a plan name change for PLN 501 from the accident and health plan to the welfare benefits plan beginning with this filing;
4. There are worksite benefits insuring 11 employees; however, these benefits are shown since they are strictly voluntary and are listed in the Wrap arrangement.
