Dear Sir/Ma'am,

My filing for my 5500SF for 2016 is late, and this is due to a misunderstanding between me and the person I spoke to last year when I called for help in filing.

I closed my practice and retired February 2016. I disbursed all the proceeds of the 401K January 31 2016. I had closed the 401K plan in December of 2015. When I spoke to the representative and explained the situation she asked me when the monies had been disbursed. I told her that they had been rolled over in January 2016; and was told that I would be required to file in 2017.

Today when I called for help, I was told that I should have filed last year by August 31 2016. I regret this error, and ask for clemency. Maybe I should have had a professional do this for me, but being such a small plan for just my tiny office I was trying to save money, and usually managed to get along fine except when I failed to report on time one year.

This will never happen again because now I am retired, there is no more plan to file and I don't have to display my ignorance.
