We have not been able to file our Form 5500 for 2015 electronically as the deadline for filing has passed. We contacted ADP, our 401K administrator and they asked that we submit a letter to you explaining why we failed to file on time.

Originally, this plan was set up for the company with ADP by an outside accountant/CPA with whom we are only working with intermittently now.
