WE CANCELLED OUR 401K POLICY DURING THAT CALENDAR YEAR AND WERE UNAWARE THAT WE NEEDED TO FILE A FINAL RETURN WE WERE NOT DIRECTED TO FILE ANY FINAL RETURN BY PAYCHEX RETIREMENT PROGRAM, EITHER BY PHONE OR EMAIL CORRESPONDENCE. THE REASON FOR CANCELLATION WAS THAT IT WAS COSTING MORE THAN THE BENEFITS REALIZED FROM IT. WE WERE RELYING UPON PAYCHEX TO ADVISE US OF OUR OBLIGATIONS AND TO PREPARE THE FORMS FOR US.
