Reasonable cause for late filing statement

Management prepared the form 5500 for 2016 and believed that it had been submitted successfully in a timely manner before the return due date. Management tracked the submission date and the originally prepared form 5500. Several years later management began to suspect that the IRS had never received its submission. Immediately upon learning that there was a chance that the IRS had not received its submission management obtained the services of a CPA to determine the status of the form 5500 for the 2016 tax year. The CPA called the IRS on March 1, 2018 and learned the IRS had not received the 2016 form 5500. Upon researching the cause it was determined that it was due to an e-filing error which caused the submission to not be received by the IRS. Immediately upon learning of these circumstances management engaged the CPA to prepare and re-submit the form 5500. We respectfully request that you allow us to file under the Delinquent Filer Voluntary Correction Program (DFVCP) since we have taken corrective action before the Department of Labor notified us of a failure to timely file an annual report under Title I of the Employee Retirement Security Act of 1974 (ERISA). Indeed we have received no notices from the department of labor regarding the late filing. Additionally management has put into place corrective procedures to guarantee that this will not occur in the future.
