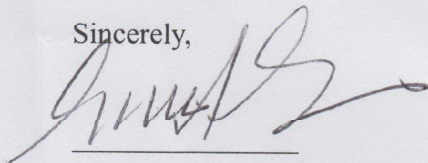
Dear Bradford,

I acknowledge and apologize for my late filing. The reasons were due to the fact that Elliot Gantz & Company, Inc. is no longer in business. The business was permanently closed in June of 2016 and dissolved shortly thereafter. We closed the plan according to instructions we received from ADP. If I, and my employee, Carol Wolf, acted under incorrect information from ADP, I again, sincerely apologize. However, we were not informed that after we closed the plan that there would be any further administration of the plan necessary. We were informed by ADP that it would be closed. We were not informed of any need to contact any of the participants further, nor that there was a previous employee still on the plan.
