Dear Sir/Madam:

We are in receipt of a letter from the IRS dated 5/27/19. Received by us on 5/29/19. As the benefits administrator for DBE I am respectfully requesting to waive any penalties associated with this late filing. We had no knowledge that we were required to file a final return. We were under the impression that the filing completed for the period ending 12/31/16 was our final return. Our 401k was being managed by our PEO provider at that time which was Paychex. Any filings that were necessary were facilitated on our behalf by them. In addition, we immediately switched from this PEO to another PEO, CoAdvantage effective 1/1/2017. This new PEO picked up all benefits management for us as well and took over this 401k filing duty. They did file a 2017 return for our company. The filing is now handled through their entity rather than our own. That said, in the transition between the two that there was some administrative oversight. We sincerely apologize for this but we honestly had no idea that this was necessary and having switched directly from one PEO to another knowing they were managing these items on our behalf assumed that all duties were being managed accordingly.
