PRIOR TO THE 2019 PLAN YEAR, THE SPONSORING EMPLOYER, NORTHWEST MEDICAL PHYSICS CENTER, PROVIDED ACCESS TO THIS 403(B) PLAN FOR IT'S EMPLOYEES. HOWEVER THE PLAN WAS A PROGRAM FOR THE PURCHASE OF ANNUITY CONTRACTS OR CUSTODIAL ACCOUNTS IN ACCORDANCE WITH PROVISIONS SET FORTH IN SECTION 403 (B) OF THE CODE AND FUNDED SOLELY THROUGH SALARY REDUCTION AGREEMENTS OR AGREEMENTS TO FOREGO AN INCREASE IN SALARY. THE PLAN WAS NOT ESTABLISHED OR MAINTAINED BY AN EMPLOYER UNDER SECTION 3(2) OF THE ACT, AND, THEREFORE, WAS NOT AN EMPLOYEE PENSION BENEFIT PLANS SUBJECT TO TITLE I OF ERISA.

PRIOR TO THE 2019 PLAN YEAR, PARTICIPATION OF EMPLOYEES WAS COMPLETELY VOLUNTARY, (2) ALL RIGHTS UNDER THE ANNUITY CONTRACTS OR CUSTODIAL ACCOUNTS WERE ENFORCEABLE SOLELY BY THE EMPLOYEE OR BENEFICIARY OF SUCH EMPLOYEE, OR BY AN AUTHORIZED REPRESENTATIVE OF SUCH EMPLOYEE OR BENEFICIARY, (3) THE INVOLVEMENT OF THE EMPLOYER WAS LIMITED TO CERTAIN OPTIONAL SPECIFIED ACTIVITIES, AND (4) THE EMPLOYER RECEIVED NO DIRECT OR INDIRECT CONSIDERATION OR COMPENSATION IN CASH OR OTHERWISE OTHER THAN REASONABLE REIMBURSEMENT TO COVER EXPENSES PROPERLY AND ACTUALLY INCURRED IN PERFORMING THE EMPLOYER'S DUTIES PURSUANT TO THE SALARY REDUCTION AGREEMENTS.

BEGINNING IN JANUARY 2019 THE SPONSORING EMPLOYER BEGAN TO PROVIDE MATCHING CONTRIBUTIONS TO THE PLAN. ACCORDINGLY, THE PLAN BECAME SUBJECT TO ERISA AND IS PROPERLY FILING A FORM 5500-SF BEGINNING WITH THE CALENDAR YEAR 2019 PLAN YEAR.
