Years Ended December 31, 2019 and 2018

1. Description of Plan:

The following description of Family Health Centers (the Organization) 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan originally effective October 1, 2002. The Plan has been amended throughout the years to comply with tax legislation and was most recently amended and restated effective April 15, 2019. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility – Employees are eligible to participate in the salary reduction arrangement in the Plan after attaining age 18 and completion of 90 days of service. Participants enter the Plan on the first day of the month coinciding with or next following the date the eligibility requirements are met. For employer matching and discretionary profit-sharing contributions, participants are eligible to participate after completing one year of service and attaining age 18. Participants are eligible for employer matching and discretionary profit-sharing contributions on the first day of the plan year or the first day of the seventh month of the plan year coinciding with or next following the date the eligibility requirements are met. In order to receive employer matching and discretionary profit-sharing contributions, an employee must complete more than 1,000 service hours during the plan year.

Contributions – The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage or a flat amount, limited by plan provisions, of their compensation contributed as pre-tax 401(k) contributions to the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan allows participants to designate contributions as Roth contributions.

The Organization may, at its discretion, elect to make a qualified matching contribution or profit-sharing contribution to the Plan. For the years ended December 31, 2019 and 2018, the Organization made no matching or profit-sharing contributions.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans or conduit Individual Retirement Accounts. Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts – Each participant's account is credited with the participant's contributions, the Organization's matching contribution, an allocation of the Organization's profit-sharing contribution, and an allocation of the Plan's earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Description of Plan (continued):

Vesting – Participants are immediately vested in their salary deferral contributions plus actual earnings thereon. Vesting in the Organization’s matching and profit-sharing contribution portion of their accounts, plus actual earnings thereon, is based on years of credited service as set forth in the following table. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

Benefit payments – Upon termination of service, retirement, death, or disability, a participant may elect to receive an amount equal to the value of the participant’s vested interest in his or her account in a lump-sum distribution. The Plan allows for in-service distributions if a participant reaches age 59 ½ and hardship distributions subject to plan provisions. If a participant terminates employment and the participant’s account balance does not exceed \$1,000, the plan administrator will authorize the benefit payment without the participant’s consent. If the balance of the terminated participant’s account is between \$1,000 and \$5,000, the plan sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant’s name.

Administration of the Plan – The Plan is administered by the Organization in the form of an advisory committee. Plan assets are invested in accordance with the employee’s instructions. Records of participant account activity are processed and maintained by John Hancock Life Insurance Company (U.S.A.), which also performs other administrative support services for the Plan. Certain administrative functions are performed by officers or employees of the Organization. No such officer or employee receives compensation from the Plan.

Forfeited accounts – Plan forfeitures arise as a result of participants who terminate service with the Organization before becoming 100 percent vested in the Organization’s contributions. These forfeitures may be used to pay administrative expenses or Organization contributions. For the years ended December 31, 2019 and 2018, there were no forfeitures used to pay administrative expenses or reduce the Organization contributions.

Plan termination – Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, the participants would become 100 percent vested in their accounts.

2. Summary of Significant Accounting Policies:

Basis of accounting – The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of estimates – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment valuation and income recognition – Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investments in the pooled separate accounts are valued using the net asset value of units, which is based on observable market prices for the underlying assets held by the Plan at year end.

Purchases and sales of shares are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative expenses – As provided in the plan document, administrative expenses may be paid either by the Plan or by the Organization. The Organization has historically paid the administrative expenses for the Plan.

Subsequent events – In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through September 28, 2020, the date the financial statements were available to be issued.

3. Information Certified by the Plan Custodian:

The plan administrator has elected the method of compliance permitted by Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, as permitted under such election, no independent auditing procedures were performed with respect to the information certified by John Hancock Life Insurance Company (U.S.A.).

John Hancock Life Insurance Company (U.S.A.), the custodian of the Plan, has supplied the plan administrator with a certification as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2019 and 2018, the statement of changes in net assets available for benefits for the year ended December 31, 2019, and the supplemental schedule of assets (held at end of year) as of December 31, 2019.

4. Fair Value Measurements:

Financial Accounting Standards Board *Accounting Standards Codification* 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the valuation methodologies used at December 31, 2019 or 2018.

Following is a description of the valuation methodologies used for assets measured at fair value.

- *Pooled separate accounts:* The fair value of the units held in pooled separate accounts is based on observable market prices of the underlying investments in the account and is based on the net asset value of the shares held by the Plan at year end.
- *Guaranteed interest accounts:* Investments in guaranteed investment contracts are valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer. Because the participants transact at contract value, fair value is determined annually for financial statement reporting purposes only. In determining the reasonableness of the methodology, plan management evaluates a variety of factors including review of existing contracts, economic conditions, industry and market developments, and overall credit ratings. Certain unobservable inputs are assessed through review of contract terms (for example, duration or payout date) while others are substantiated utilizing available market data (for example, swap curve rate).

4. Fair Value Measurements (continued):

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in fair value levels – The availability of observable market data is monitored to assess the appropriate classifications of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

We evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. 5. Group Annuity Contract with Insurance Company:

In 2002, the Plan entered into a group annuity contract with John Hancock Life Insurance Company (U.S.A.) (John Hancock). The guaranteed interest accounts are not investment contracts, but investment options offered under the John Hancock group annuity contract. John Hancock maintains the contributions in a general account. Guaranteed accounts guarantee the return of principal plus compound interest earned over a defined three, five, or ten-year term and charge for participant withdrawals and administrative expenses. The guaranteed accounts are not considered fully benefit-responsive.

There is no contract rate and no minimum rate. Interest rates are established on the first day of each calendar month and apply to all regular ongoing contributions made to the guaranteed account in that month for all contract holders. This is called the “new money” regular rate. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the guaranteed accounts approximates fair value at December 31, 2019 and 2018.

6. Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

7. Plan Tax Status:

The Organization adopted a nonstandard prototype document with an IRS notification letter dated September 30, 2014, which states the prototype plan document is qualified pursuant to the appropriate sections of the IRC. The Plan has obtained a favorable determination letter from the IRS but has since been amended. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, they believe that the Plan is qualified and the related trust is tax-exempt as of the financial statement dates. Accordingly, no provisions for income taxes have been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2019, there are no uncertain tax positions taken or expected to be taken that would require recognition of the liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, and the Plan could be subject to income tax if certain issues were found by the IRS that could result in the disqualification of the Plan's tax-exempt status; however, there are no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for the years prior to 2016.

8. Party-in-interest Transactions:

Certain plan investments are units of pooled separate accounts and guaranteed interest accounts managed by John Hancock, the Plan's insurance company. The guaranteed interest accounts are not maintained separately from the general assets of John Hancock. Therefore, these transactions qualify as party-in-interest transactions. Certain other fees for investment services paid by the Plan are included in the net depreciation in fair value of investments, as they are paid through revenue sharing rather than direct payment. The plan sponsor pays directly any other fees related to the Plan's operations.

Other party-in-interest transactions follow:

- The plan sponsor provides to the Plan certain accounting and administrative services for which no fees are charged to the Plan. The employees that provide these services also are participants in the Plan.
- The Plan relies on a third-party service provider, AmeriBen/IEC Group, to process the Plan's investment transactions and to manage the individual participant accounts of the Plan.
- The plan auditor performs the required annual audit of the Plan.

9. Subsequent Event:

On March 11, 2020, the World Health Organization declared COVID-19 a pandemic. The COVID-19 pandemic and resulting global disruptions have caused significant economic uncertainty and volatility in financial markets. As a result, the Plan's various investment securities have incurred significant declines in fair value since December 31, 2019. The impact of COVID-19 continues to evolve rapidly and the Plan is not able at this time to estimate its full impact on the Plan's financial statements.
