NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2019 AND 2018

NOTE 1 - DESCRIPTION OF PLAN:

The following description of the Westport Retirement Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

GENERAL:

The name of the Plan is Westport Retirement Plan. The sponsor of the Plan is the employer:

Galliano, Louisiana 70354

The Plan is a defined contribution Plan 401(k) savings and is administered by the employer. The trustee for the Plan is the Fidelity Personal Trust Company, FSB. The agent for service of legal process is the Plan administrator.

ELIGIBILITY - SALARY REDUCTION:

In accordance with the Plan terms, employees are eligible for the Plan if they were employed on the Plan's effective date (January 1, 1980). New employees are eligible to enter the Plan on the first day of the month coinciding with or next following the date on which they complete six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

ELIGIBILITY - EMPLOYER CONTRIBUTIONS:

In accordance with the Plan terms, participants in the salary reduction features of the Plan may become eligible for employer matching contributions.

CONTRIBUTIONS:

Participants may elect to defer a portion of their compensation each pay period. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Deferral amounts during any calendar year are limited to a maximum dollar amount allowed by law. Participants direct the investment of their contributions into various investment options offered by the Plan.

NOTE 1 - DESCRIPTION OF PLAN: (Continued)

CONTRIBUTIONS: (Continued)

The employer makes a matching contribution in an amount equal to a percentage of employee salary deferrals. Such percentage is discretionary and is determined by the employer as of the first day of each Plan year. The employer match is limited to the deferred amounts or 6% of compensation whichever is less. The employer suspended matching contributions for the Plan year's 2019 and 2018.

Rollover contributions are allowable under the Plan but are subject to various requirements stated in the Plan document.

PARTICIPANT ACCOUNTS:

The Plan maintains separate contribution accounts on behalf of each participant. Participants are credited with their contribution (salary deferral), the employer matching contribution, any rollover contribution as well as investment earnings and losses on these funds.

VESTING:

Participants are immediately vested in their contributions plus actual earnings thereon.

Participant vesting on matching contributions is generally based on years of service. A participant is 100% vested after six years of credited service. Participants are credited with a year of service for vesting for each Plan year during which they complete 1,000 or more hours of service. For vesting purposes, all years of service completed since a participant's date of employment are taken into account. The Plan provides for full vesting in the event of death, permanent and total disability or upon attainment of normal or early retirement age under the Plan.

The vesting schedule on termination of employment is as follows:

NOTES RECEIVABLE FROM PARTICIPANTS:

The Plan allows for loans to all participants who maintain an account balance under the Plan.

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Such loans shall be secured by the participant's vested account balance.

NOTE 1 - DESCRIPTION OF PLAN: (Continued)

NOTES RECEIVABLE FROM PARTICIPANTS: (Continued)

Interest rates on loans range from 4.25% to 6.50% which are commensurate with local prevailing rates as determined on the first day of each calendar quarter by the Plan Administrator. Principal and interest is paid according to the loan payout schedule on each loan.

PAYMENT OF BENEFITS:

The Plan provides for the payment of benefits in the event of death, permanent and total disability, attainment of age 59 1/2 or upon attainment of normal or early retirement age. If terminated before retirement, participants are entitled to 100% of their salary deferrals and a percentage of their employer contribution account in accordance with vesting percentages based on years of service.

FORFEITED ACCOUNTS:

Forfeited amounts that occur during a Plan year may be used to pay employer matching contributions as well as administrative and recordkeeping fees.

PLAN AND ADMINISTRATIVE FEES:

Plan expenses are generally paid by the Plan sponsor, except for amounts paid from participant forfeitures used to pay employer matching contributions and other administrative fees. Loan service fees are paid by the affected participants of the Plan.

TERMINATION OF PLAN:

The employer may elect to terminate the Plan at any time. In the event of Plan termination, participants will become fully vested in their account balances. Since the Plan is a defined contribution Plan, benefits under the Plan are not insured by the Pension Benefit Guaranty Corporation if the Plan terminates.

ADMINISTRATION:

The Plan administrator shall have all authority necessary or incidental to carrying out the intent and purpose of the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

BASIS OF ACCOUNTING:

The financial statements of the Plan are prepared on the accrual basis of accounting.

INVESTMENT VALUATION:

Where available, quoted market prices are used to value investments. Estimated fair market values are used for investments which have no quoted market price. See Note 5 for discussion of fair value measurements.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES: (Continued)

NOTES RECEIVABLE FROM PARTICIPANTS:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

NOTE 3 - USE OF ESTIMATES IN THE PREPARATION OF FINANCIAL STATEMENTS:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

NOTE 4 - INFORMATION PREPARED AND CERTIFIED BY TRUSTEE (UNAUDITED):

The Plan's investments are maintained by the trustee, Fidelity Personal Trust Company, FSB. The Plan administrator has instructed the independent public accountants not to examine the information certified as complete and accurate by the trustee. The trustee's certification applies to substantially all Plan assets and related transactions for the dates presented.

NOTE 5 - FAIR VALUE MEASUREMENTS:

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels as follows:

Level 1 - Inputs consist of quoted prices in active markets for identical assets and have the highest priority.

Level 2 - Observable inputs other than quoted prices for the asset, either directly or indirectly observable, that reflect assumptions market participants would use to price the asset based on market data obtained from sources independent of the Plan.

Level 3 - Unobservable inputs that reflect the Plan's own assumptions about the assumptions market participants would use to price an asset based on the best information available in the circumstances.

NOTE 5 - FAIR VALUE MEASUREMENTS:

(Continued)

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

The following is a description of the valuation methodologies used for the Plan's investments measured at fair value. There have been no changes in the methodologies used at December 31, 2019 and 2018.

- Mutual Funds - Valued at the net asset value of shares held by the Plan at year end.
- Common / Collective Trusts - Valuation is based on the estimated fair value of the underlying securities and the estimated value of the wrapper contract.

NOTE 7 - NOTES RECEIVABLE FROM PARTICIPANTS:

Balances on participant loans at December 31, 2019 and 2018 amounted to \$564,174 and \$571,834 respectively. As of December 31, 2019 and 2018, no allowance for credit losses has been recorded. Participant loans determined to be in default by the Plan Administrator are recorded as a benefit payment based on the terms of the plan document.

NOTE 8 - INCOME TAX STATUS:

The Plan is a prototype plan which obtained a determination letter on March 31, 2008, in which the Internal Revenue Service stated that the Plan meets the qualifying requirements of the Internal Revenue Code. The Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan is subject to income tax examinations for the years 2013 through 2019.

NOTE 9 - EMPLOYER CONTRIBUTIONS
AND ADMINISTRATIVE FEES:

There were no employer contributions for the Plan years ended December 31, 2019 and 2018.

There were no forfeited amounts for the year ended December 31, 2019. Forfeitures used to pay administrative expenses for the year 2019 amounted to zero. Forfeited nonvested accounts totaled \$1 at December 31, 2019.

NOTE 10 - TOP-HEAVY STATUS:

For the Plan year ended December 31, 2019, the Plan was determined not to be top heavy.

NOTE 11 - RISK AND UNCERTAINTIES:

The Plan invests in a variety of investment funds. Investments in general are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 12 - PLAN AMENDMENTS:

Effective January 1, 2019, hardship distributions are now permitted from all participant accounts. Distributions may only be made from accounts which are fully vested.

NOTE 13 - CONTINGENCIES:

There are no known contingent liabilities at December 31, 2019.

NOTE 14 - SUBSEQUENT EVENTS:

The Plan has evaluated subsequent events through October 13, 2020, the date the financial statements were available to be issued. As a result of the spread of COVID-19 coronavirus, economic uncertainties have arisen which have resulted in volatility in the investment markets, resulting in changes in the value of the investments. The duration of these uncertainties and the ultimate financial effects cannot be reasonably estimated at this time.

The Plan has placed into effect for the Plan year 2020, various provisions of the CARES Act. These provisions were implemented to assist participants with plan options and is a direct result of the COVID-19 coronavirus pandemic.
