

Dear Sir or Madam,

We are writing regarding the late filing of the Form 5500-SF for Print Tech Inc 401(k) Profit Sharing Plan and Trust.

We are aware of our responsibility to file Form 5500-SF annually before the deadline. In order to ensure we fulfilled our filing obligations, we contracted with a payroll processing company. Part-way through 2020, we discontinued our business relationship with this company.

On October 14th, one day before the Form 5500-SF deadline, our payroll processing company informed us that they had filed an extension using Form 5558 for the plan, but had not filed Form 5500-SF on our behalf. Upon discovering this, we immediately contacted a third party to assist us in preparing Form 5500-SF. However, due to the last-minute gathering of information and the coinciding of October 15th with the Form 1040 filing deadline, Form 5500-SF was not filed until October 16th, a single day after the deadline.

As you can see, this was an inadvertent error and we took immediate action to correct this error upon discovery. We relied on a professional who we just discovered did not fulfill their side of the obligation. Therefore, we respectfully request abatement of the \$750 penalty for late filing Form 5500-SF for 2019.
