Community Resources Group underwent significant changes in their accounting department:

1. The long-term accounting employee retired in August and was replaced with a contractor.
2. In April of 2020 the payroll function was contracted out to a Professional Employer Organization (PEO) and had significant difficulties with the transition.
3. Our contracted accountant was added to our retirement account as a user, but did not have access to the 5500 filing, and was not aware of the needed information for completion of the 5500.
