I am writing to you to request an abatement of the penalty for the late filing of the form 5500.

This is the first time that I had to fill out this form as I started offering a 401K to my employees in 2019. My practice was a solo practice and I was the plan administrator as well as being the practice owner. Due to COVID-19, my practice suffered severe financial hardship and I had to close on May 31, 2020. I am currently an employee of a new, group practice and trying to complete my duties related to my former practice.

As I am not very familiar with the regulations and requirements of administering a 401K plan, I did not fully comprehend the necessity and importance of filing the Form 5500. I would really appreciate your consideration of my practice situation as well as my lack of experience with the 401K plan. I am still experiencing hardship from making no income for 3 months due to COVID and the penalty payment would make it very difficult for me financially.
