The representative had told us that we had time until May 2021 to file this form. This was not correct. It was brought to our attention after many phone calls, and conversations with representatives that we had to file this form as of 12/31/2020. We are currently 26 days late. Several of those days were lost with the back and forth, and VERY long wait times on hold with representatives with paychex, efast, and the IRS due to the covid pandemic. This is a retirement plan that had been closed. It was brought to my attention after the fact that I was supposed to continue filing the form 5500 which I am trying to rectify. This is a small retirement plan that was put forth at the time with the company we were using. We are currently not with them at all. We are waiting for a call back from a special agent from the Delinquent Filing team to help us with the calculation for payment. If you can please have it in you to forgive my lateness and I am asking for any penalties' to be waived.
