We serve adult, mentally challenged clients with job placement and maintenance to allow them access to highly beneficial, real world workplaces. Our company has four employees.

I assumed the position of Executive Director in 2018. When trained and oriented for the position, neither the previous Executive Director nor our corporate accountant informed me about the requirements involving the use of Form 5500-F. It wasn't until 2020, when we changed accountants, that I made aware of the Form and its requirements. I mention this only because I want to make it clear that I was not wontedly avoiding the payment responsibilities. I realize that "ignorance is no excuse for the law" – it's simply my sole reason.

I have now completed the late 2018 and 2019 submittals. I am committed to promptly following up and finishing the same for 2020. Moving forward, we will stay current with this submission requirement.

As our firm is a non-profit, small and 100% dependent upon County funding for our no frills operations. It would mean everything if the IRS could forgive the late payment penalties and fees that have been assessed on the attached 2018-2019 5500-SF. We want to avoid being in a position of facing significant hardship to our employment picture and the services we provide.
