I have attempted to file form 5500 timely on several occasions. I tried to file it in June and also in July. However for some reason it would not accept my credentials. I verified my credentials and everything was correct. I contacted aba retirement plans for assistance and was on the phone with them for a period of time while they tried to fix it. He put me on hold and spoke to another person about it and they could not figure it out. The person on the phone was unable to fix it and instructed me to send an email, which I did on July 27, 2021. I did not hear back from them and sent another email on August 16, 2021 attempting to follow up with them without a response. I called them today as I got a reminder and it is not clear if the issue has been fixed.
