1. DESCRIPTION OF PLAN

The following description of Cobalt Enterprises 401(k) Plan (the Plan) provides general information only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

a. General

The Plan is a qualified defined contribution plan established on February 1, 2014. The Plan covers all employees of Cobalt Enterprises, LLC (the Company) who are not in an ineligible class of employees as defined by the Plan.

The Plan is subject to the provisions of Employee Retirement Income Security Act of 1974 (ERISA).

b. Eligibility

All employees who are at least 18 years of age are eligible to participate in the Plan once they have completed three months of service. Employees can elect to enter the Plan as a participant on the first day of the quarter following the date on which they satisfy the service requirement.

c. Contributions

Each year, participants may contribute up to 100% of their eligible compensation, as defined in the Plan.

Upon meeting the eligibility requirements, employees are automatically enrolled into the Plan at a pretax deferral rate of 6% of their gross compensation each pay period. Employees can elect to opt-out of participating in the Plan. Employees may choose between Pre-tax and Roth contributions in their elective deferrals. Participants are allowed to make modifications to their contributions weekly.

The Company has a safe harbor matching contribution feature. Under the terms of the safe harbor provisions, the Company matches employee contributions in an amount equal to 100% of the first 2% of eligible compensation and 50% of the next 4%, that the participant contributes to the Plan, up to a maximum of 4% of the participant's eligible compensation.

The Company may also make qualified safe harbor matching and discretionary matching contributions to the Plan. For 2020, no qualified safe harbor matching or discretionary matching contributions were made.

Participants may contribute amounts representing distributions from other qualified defined contribution or defined benefit plans (rollover).

Participants direct the investment of their contributions and employer contributions into various investment options offered by the Plan. Participants may change their investment options as often as permitted under the investment vehicles they choose.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

d. Participant accounts

Each participant's account is credited with the participant's contributions and the Company's safe harbor matching contribution, and an allocation of plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

e. Vesting

Participants are immediately vested in their voluntary and safe harbor matching contributions plus actual earnings or losses thereon.

Vesting in the Company's qualified safe harbor matching contributions and the discretionary matching contributions are based on years of service. Employees hired before January 1, 2019 are 100% vested in the qualified safe harbor matching contributions even if they are not yet a participant in the Plan. Employees hired on or after January 1, 2019 are subject to the 2-yr cliff vesting schedule. Any employee who was a participant in the Plan as of March 1, 2017 will be 100% vested in all sources. All other employees will be subject to the 6-year graded vesting schedule for discretionary matching contributions.

Upon death, disability or reaching normal retirement age (age 65), participants become fully vested in all account balances.

f. Payment of benefits

Benefits will be paid to the participants or participant's beneficiary upon termination of service, death, disability, or retirement.

If the participant's vested benefit is over \$1,000, then the participant must consent to the distribution before it may be made. The participants may elect to receive a distribution either through a rollover or receive the distribution directly.

If the participant's account balance is under \$1,000, then the distribution will be automatically made in a lump sum cash payment regardless of whether the participant consents to receive it.

Participants may also withdraw funds from their account in the event of financial hardship as defined in the Plan document.

g. Forfeited accounts

At both December 31, 2020 and 2019, forfeited nonvested account balances totaled \$0. These balances can be used to pay administrative expenses or be used to reduce employer contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

a. Basis of accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

b. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

c. Investment valuation and income recognition

Investments are stated at fair value (except for fully benefit responsive investment contracts, which are required to be reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

d. Payment of benefits

Benefits are recorded when paid.

e. Administrative expenses

Certain expenses incurred by the Plan are paid by the Company and are excluded from these financial statements. Investment and record keeping fees are either paid out of the participant accounts on a per capita basis or paid by the Company on behalf of the Plan. Transaction based fees are charged directly to the participant accounts.

f. Date of the Plan's review

The Plan has evaluated subsequent events through September 29, 2021, the date the financial statements were available to be issued.

3. CUSTODIAN CERTIFICATION AND LIMITATION ON SCOPE OF AUDITOR'S REPORT

The plan sponsor has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the scope of the auditors' examination did not extend to the following information certified by the custodian as complete and accurate:

- Investments
- Net appreciation in fair value of investments
- Interest and dividends
- Schedule of assets (held at end of year)

4. FAIR VALUE MEASUREMENTS

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2020 and 2019.

*Pooled separate accounts:* The daily net asset value (NAV) is used as a practical expedient to estimate fair value. Investments in pooled separate accounts (PSAs) represent ownership of units of participation (Units), rather than ownership of specific assets. The value of any one PSA is determined by aggregating the value of all the Units held by the Plan. The value of a single Unit is the total value of the PSA's underlying investments plus other assets less liabilities divided by the number of Units outstanding. Investments in the PSAs are valued at a net asset value per share method (unit pricing) which is generally determined by the quoted market price of the underlying investments.

There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

5. GUARANTEED FUND

The Plan has a fully benefit-responsive investment contract with Sentry Life Insurance Company (Sentry). Sentry maintains the contributions in a general account. Specific securities within the general account are not attributed to the guaranteed fund. The account is charged for participant withdrawals and administrative expenses. Sentry is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria in accordance with ASU 2015-12 and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Sentry, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

5. GUARANTEED FUND, (Continued)

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code (IRC) or the failure of the trust to be tax-exempt under Section 501(a) of the IRC.
- Premature termination of the contract.
- Plan termination or merger.
- Changes to the Plan's prohibition on competing investment options.
- Bankruptcy of the plan sponsor or other plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines.
- A breach of material obligation under the contract.
- A material misrepresentation.
- A material amendment to the agreement, with the consent of the issuer.

6. PARTY-IN-INTEREST TRANSACTIONS

During 2020 and 2019, the Plan held investments in fund options managed by Sentry Life Insurance Company (Sentry). Sentry is the custodian as defined by the Plan and, therefore, these transactions are recognized as exempt party-in-interest transactions under ERISA.

For the year ended December 31, 2020, the Plan paid \$4,032 for certain expenses related to the plan operations to various service providers. These expenses are recognized as exempt party-in-interest transactions under ERISA.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will be 100% vested in their accounts.

8. TAX STATUS

The Plan utilizes a Defined Contribution Prototype Plan document administered by Sentry Life Insurance Company. The Prototype Plan obtained a determination letter dated March 31, 2014 from the IRS, which states that the Plan, as designed, complied with applicable requirements of the Internal Revenue Code (IRC) and, accordingly, was exempt from federal income tax. Although the Plan has been amended since receiving the determination letter, the plan administrator and the plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net assets Available for Benefits.

10. REGULATORY CHANGES

SECURE Act

The Setting Every Community Up for Retirement Enhancement (SECURE) Act was signed into law on December 20, 2019, though the changes became effective beginning in 2020 and subsequent periods.

The Company is currently working with its service providers to ensure any applicable provisions of the SECURE Act are being implemented into plan operations and any necessary amendments to the Plan are being prepared in a timely manner.

CARES Act

During 2020, the COVID-19 virus spread to the United States of America. Effective March 2020, the World Health Organization declared the virus outbreak a pandemic. COVID-19 led to significant volatility in financial markets and had a significant impact on national and local economies as a whole.

In response to the pandemic, the Federal Government signed into law the Coronavirus Aid, Relief, and Economic Security (CARES) Act. The CARES Act provided economic relief in various forms, including retirement plan provisions that allowed for coronavirus-related distributions and loans, and waived required minimum distribution requirements for the calendar year 2020.

10. REGULATORY CHANGES, (Continued)

Under the CARES Act, plan management was given the option to adopt these provisions immediately, provided the plan agreement was retroactively amended on or before December 31, 2022. Plan management elected not to adopt the relief provisions of the CARES Act.
