We are responding on behalf of the above referenced client to assist with the administrative functions associated with the above referenced retirement Plan. Our client, **Greenfield Commerce Solutions, LLC** provided us with a copy of Notice CP216H and has asked us to reply to you on their behalf.

With respect to the Plan and Plan Year in question, our records show that on July 28<sup>th</sup>, 2021, we mailed Form 5558 requesting an extension of time to file Form 5500-SF and Form 8955-SSA on or before October 15<sup>th</sup>, 2021. The filing and request were sent via U.S. Postal Service. We are still looking into additional issues with some of the mailings.

We mailed Form 5558 in good faith. If your records show a processing date that is not sufficient, then it appears the U.S. Postal Service may still be experiencing some operational delays caused by the impact of COVID-19. Neither Cerberus Retirement nor the above client, have previously had a delinquent extension or filing. Cerberus Retirement will also attempt to have all future extensions mailed with additional delivery and processing time to accommodate current conditions. Accordingly, we respectfully ask you to reconsider and approve our request for the extension of time to file Form 5500-SF and Form 8955-SSA. Moreover, these penalties would cause hardship and we respectfully ask that no penalties are imposed.
