**Note 1 - DESCRIPTION OF PLAN**

The following description of the Rainier Asphalt Safe Harbor 401(k) Plan (the "plan") provides only general information. Participants should refer to the plan document or Summary Plan Description for a more complete description of the plan's provisions, which are available from the plan administrator.

**GENERAL**

The plan is a defined contribution plan sponsored by Rainier Asphalt Sealing, LLC (the "company") for the benefit of its full-time employees beginning on the first day of employment excluding union employees, leased employees and non-resident aliens with no earned income in the United States are not eligible to participate in the plan. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**CONTRIBUTIONS**

Participants may contribute a percentage of eligible annual compensation as pre-tax or Roth contributions, as defined in the plan agreement. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older, who are making contributions to the plan, are allowed to make catch-up contributions as defined in the plan. Participants direct the investment of all contributions into various investment options offered by the plan. The plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the plan unless they affirmatively elect not to participate in the plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The automatic deferral percentage will increase by 1% per year up to a maximum of 6% of eligible compensation. The company makes safe harbor contributions equal to 3% of the of a participant's base compensation to the plan. Additional amounts may be contributed at the option of the company. Contributions are subject to certain Internal Revenue Code ("IRC") limitations. Effective January 1, 2021 the plan terminated the automatic enrollment and automatic deferral percentage features.

The company contributes to the profit sharing plan in the greater of amounts specified by any Federal, State, County or publicly funded contract entered into, including prevailing wage contributions on behalf of participants who perform services subject to the Davis-Bacon Act, the Service Contract Act, or any similar federal, state, or municipal prevailing wage statutes, or 3% of compensation.

**PARTICIPANT INVESTMENT ACCOUNT OPTIONS**

The plan currently offers sixteen mutual funds and a stable value common collective trust as investment options for participants. Participants may purchase shares of mutual funds, common stocks, and U.S. government securities not offered by the plan through the brokerage account. There are no non-participant directed investments.

**PARTICIPANT ACCOUNTS**

Each participant's account is credited with the participant's contribution and allocations of (a) the company's contribution and (b) plan earnings, and charged with an allocation of administrative

expenses. Allocations are based on participant earnings or account balances, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **VESTING**

Participants are immediately vested in their contributions and company Davis-Bacon, safe harbor and profit sharing contributions plus actual earnings thereon.

#### **PAYMENT OF BENEFITS**

On termination of service due to death, disability or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other than death, disability or retirement, a participant will receive an automatic benefit payment for the value of the vested interest in his or her account as a cash lump sum for balances under \$5,000.

### **Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### **BASIS OF ACCOUNTING**

The financial statements of the plan are prepared on the accrual method of accounting.

#### **USE OF ESTIMATES**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

#### **NEW ACCOUNTING PRONOUNCEMENTS**

In August 2018, the FASB issued ASU 2018-13, "*Fair Value Measurement - Disclosure Framework (Topic 820)*". The updated guidance improves the disclosure requirements on fair value measurements. The updated guidance is effective for fiscal years beginning after December 15, 2019. Early adoption is permitted for any removed or modified disclosures. The adoption of ASU 2018-13 did not have a material impact on the plan's financial statements.

#### **INVESTMENT VALUATION AND INCOME RECOGNITION**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold, as well as held during the year.

#### **PAYMENT OF BENEFITS**

Benefits are recorded when paid.



**ADMINISTRATIVE EXPENSES**

Certain expenses of the plan are paid by the company and are not included in the accompanying financial statements. Certain expenses of maintaining the plan are paid by the plan and included in administrative expenses. Additionally, fees related to distributions from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Note 3 - INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Transamerica Insurance Company, Inc., the custodian of the plan, has certified that the following data included in the accompanying 2020 financial statements and supplemental schedule are complete and accurate with respect to investments:

- Investments at fair value
- Net appreciation in fair value of investments
- Schedule H, Line 4(i) - Schedule of Assets (held at end of year)

The plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**Note 4 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2020 and 2019.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

*Stable value common collective trust:* A stable value fund that is composed primarily of fully benefit-responsive investment contracts is valued at the NAV of units of the bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. If the plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

**Note 5 - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

The Transamerica Stable Value Core is managed by Transamerica Life Insurance Company. Transamerica Life Insurance Company is the custodian for the plan and therefore, these transactions qualify as party-in-interest transactions. As described in Note 2, the plan made direct payments to the custodian of \$11,911 and \$10,984 for the years ended December 31, 2020 and 2019.

**Note 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA.

**Note 7 - TAX STATUS**

The Internal Revenue Service ("IRS") has determined that the prototype 401(k) profit sharing plan is designed in accordance with applicable sections of the IRC and informed the third party administrator such in a letter dated March 31, 2014. Although the plan has been amended since receiving the opinion letter, the plan administrator believes that the plan is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8 - RISKS, UNCERTAINTIES AND CONCENTRATIONS**

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

At December 31, 2020, approximately 21% and 20% of the plan's investments were invested in American Funds Growth and Invesco Small Cap Equity Ret Opt, respectively.

On January 30, 2020, the World Health Organization ("WHO") announced a global health emergency because of the coronavirus (the "COVID-19 outbreak") creating risks to the international community as the virus spread globally. On March 11, 2020, the WHO classified the COVID-19 outbreak as a pandemic, based on the rapid increase in exposure globally.

The full impact of the COVID-19 outbreak continues to evolve as of the date of this report. The pandemic has adversely affected global economic activity and greatly contributed to significant instability in financial markets. As a result, there has been a heightened market risk and the plan's investment portfolio has experienced significant volatility in fair value in response to changing market conditions, which has been reflected within the net appreciation in fair value of investments reported in the statement of net assets available for benefits. Plan management will continue to monitor the impact COVID-19 has on the plan and will reflect the results as appropriate in the plan's financial records.

**Note 9 - SUBSEQUENT EVENTS**

The plan has evaluated subsequent events through October 11, 2021, which is the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.
