

Attention Examiner:

I have just become made aware that I missed a filing deadline for the 2020 Form 5500-SF, which is the first year/report for this 401K plan initiated on February 1, 2020. The plan contributions were all made timely in accordance with applicable guidelines. The Plan administrator prepared the Form 5500 report, but I was not aware of the need for the plan sponsor to separately log into the retirement sector of the website and sign this report to authorize its filing. While planning for 2021 retirement contributions this week, I logged on to the retirement site and discovered the red flag that my signature was required, and that the deadline had been missed.

In consideration of the fact that this is the first time a report has been required as a very new plan sponsor, and that there was no financial lapse or payment caused to be late, by this delayed filing, I am requesting leniency in the application of any potential fine or penalty for the inadvertent late filing. I have since set up additional protocols to prevent this from happening in the future.
