Dear Mr. Albert:

I am in receipt of your text message dated 1/25/22 regarding my 2020 Form 5500-SF for Miss Stephanies Day Care LLC 401(k) Profit Sharing Plan & Trust. I tried to use the DFVCP as suggested in your text; however, it stated in the fact sheet that I could not use this program because I could only use it if *I had not been notified in writing by the Department of a Failure to file a timely annual report...* Therefore, I didn't think I could go that route.

I was using the payroll company Paychex at that time and left them in October 2020. I also closed out mine and my employee's 401K plan. I did file the 5500 in 2018 and 2019, but not 2020. I thought my payroll company reminded me of an upcoming filing. I called them (Paychex) today and they said they sent me a text in July reminding me. I checked my texts and there was nothing from Paychex. They said that it was ultimately my responsibility to file. I am new to running a business and the various forms from NYSCFS and others are, at times, overwhelming to me. A reminder would have been helpful.

I run a small home daycare and a substantial fine would be a big hardship for me. I am a single mom with two young children. I quit my previous job and opened my daycare so that I would be able to work and take care of my girls. If I had received a reminder from Paychex I'm sure I wouldn't be in this position. I would have filed the form.

I implore you to please waive the penalty. I personally only had two hundred dollars in the 401K. The rest was my employee's. I would greatly appreciate anything you can do for me. Thank you!
