TO: Department of Labor/IRS

We are respectfully requesting an abatement of the penalties for filing the 2020 Form 5500 late. The owner of US Dedicated LLC, Robert Hicks, had a serious medical incident (series of strokes and other serious conditions) in December 2019 and has not been able to fully resume his work capacity as of this date. I have stepped in, as his mother and Conservator/POA, to keep his 2 businesses running and keep his employees on the payroll. However, Robert has needed 24-hour care, ongoing rehabilitation, medical appointments, and a series of medical issues, making it impossible for me to file the Form 5500 in a timely manner. I am also a healthcare provider and work part time, in addition to all of these added duties on behalf of my son. Further, we have terminated the 401k Plan for US Dedicated LLC as of April 30, 2021 and I understood that all of the 3 employees had rolled over their investments in order to close their accounts. However, I did not realize that one of the previous employees who was terminated from the company in August 2020 still had his 401k account open in 2021. I have been overwhelmed by all of duties I am trying to cover for my son in keeping his 2 businesses afloat and retaining employees that this requirement was unfortunately not completed in a timely manner. The penalty fee will also be a financial burden on US Dedicated LLC since the cash flow for this small business since Robert's medical condition, as well as the pandemic, has negatively impacted the business.
