I have just discovered that I did not complete Form 5500-SF in a timely manner for our school. I am requesting a waiver for the penalties for late filing, especially since this would cause a hardship for our organization.

I assumed, incorrectly, that I wasn't able to send the Form 5500-SF in until we had completed the Non-Discrimination Compliance for the year-end census. I had a series of emails with additional requests for information from our 401(k) manager at Saturna, which were resolved June 3rd. It was just today that our service manager realized that we hadn't completed the 5500, even though he had sent me the original notification April 21, 2022.

This has been an overwhelming two years, and I do hope that your department will consider waiving any penalties connected to this late filing.
