As permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator instructed the predecessor auditor not to perform, and they did not perform, any auditing procedures with respect to the information certified by a qualified institution. Their report dated October 7, 2021, indicated that (a) because of the significance of the information that they did not audit, they were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion and accordingly, they did not express an opinion on the 2020 financial statements and supplemental schedule, and (b) the form and content of the information included in the 2020 financial statements and supplemental schedule other than that derived from the certified information, was presented in compliance with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF PLAN

The following description of the Brusco Tug and Barge, Inc. Employees Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

a. General

The Plan is a defined contribution plan established on January 1, 1993. The Plan covers all employees of Brusco Tug and Barge, Inc. (the Company) that are not in an ineligible class of employee as defined by the Plan Agreement.

Effective January 1, 2022, the Plan was amended and restated to comply with current regulations and to remain qualified as a tax-exempt Plan. General operating provisions of the Plan were not modified with respect to this amendment. This amendment also adopted the regulatory changes identified in note 9.

The Company is also the plan sponsor and plan administrator.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

b. Eligibility

Employees are eligible to contribute elective deferrals in the Plan immediately upon hire.

Employees are eligible for matching and nonelective contributions upon completion of one year of service. Eligible entry for matching and nonelective contributions begins on the first day of the Plan year or the first day of the seventh month of the Plan year, coinciding with or next following, the completion of the service requirement.

c. Contributions

Participants may elect to defer and contribute a portion of their compensation, as defined by the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Plan has a matching contribution feature. Under the terms of the matching provisions, the plan sponsor may make a discretionary matching contribution. For the year ended December 31, 2021, the Company elected a discretionary matching contribution of up to 3% of eligible compensation, capped at \$5,000.

The Company may also make discretionary qualified nonelective contributions. There were no such contributions made for the year ended December 31, 2021.

1. DESCRIPTION OF PLAN, (Continued)

c. Contributions, (Continued)

Participants direct the investment of their contributions and employer contributions into various investment options offered by the Plan. Participants may change their investment elections as often as permitted under the Plan and the investment vehicle they choose.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

d. Participant accounts

Each participant's account is credited with the participant's voluntary contributions, the employer's matching contributions, and an allocation of plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

e. Vesting

The participants are fully vested at all times in their salary deferral contributions plus actual earnings or losses thereon.

The vesting schedule for employer matching and qualified nonelective contributions, and earnings or losses thereon is as follows:

Upon death, disability or reaching normal retirement age (62 years old), participants become fully vested in all account balances.

f. Payment of benefits

Benefits will be paid to the participants or participant's beneficiary upon termination of service, death, disability or retirement.

Benefits will be paid either as a lump-sum or in installment payments, at the participant's discretion.

If the participant's vested benefit under the Plan exceeds \$1,000, then the participant or participant's beneficiary must give consent before the distribution may be made.

1. DESCRIPTION OF PLAN, (Continued)

f. Payment of benefits, (Continued)

If the participant's vested benefit under the Plan does not exceed \$1,000, then the benefit may be distributed in a single lump-sum payment as soon as possible following the event that entitles the participant to a distribution, at the discretion of the plan administrator.

The Plan allows in-service distributions to participants who have reached age 55.

Participants may also withdraw funds from their vested account in the event of financial hardship as defined by the Plan.

g. Forfeitures

Forfeited account balances will be used first to offset employer contributions and then used to reduce plan administrative expenses under the Plan and finally, any remaining forfeitures will be allocated to participants.

At December 31, 2021 and 2020, there were forfeited, non-vested accounts of \$9,554 and \$7,370, respectively. No forfeitures were used to reduce employer matching contributions or plan administrative expenses during 2021.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

a. Basis of accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

b. Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

c. Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment adviser and trustee. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

d. Payment of benefits

Benefits are recorded when paid.

e. Administrative expenses

Transaction based fees are charged directly to participants' accounts. Certain administrative expenses are paid by the Company and are not reflected in these financial statements. Administrative expenses paid by the Plan are charged to participants' accounts and apportioned based upon their relative account values. Investment related expenses are included in net appreciation of fair value of investments.

f. Date of the Plan's review

The Plan has evaluated subsequent events through October 14, 2022, the date the financial statements were available to be issued.

3. TRUSTEE CERTIFICATION UNDER ERISA SECTION 103(a)(3)(C)

The plan sponsor has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the scope of the auditors' examination did not extend to the following information certified by the trustee as complete and accurate:

- Cash, non-interest bearing
- Investments
- Net appreciation in fair value of investments
- Interest and dividends
- Schedule of assets (held at end of year)

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

4. FAIR VALUE MEASUREMENTS, (Continued)

Level 2 Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs that are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2021 and 2020.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Stable value collective trust fund:* Valued at the NAV of units of the stable value collective trust fund. The NAV, as provided by the fund's trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell an investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective investment fund, the investment trustee reserves the right to temporarily delay withdrawal from the trust for twelve months.

5. PARTY-IN-INTEREST TRANSACTIONS

For the year ended December 31, 2021, the Plan paid \$44,556 for certain expenses related to plan operations and investment activity to various service providers. These expenses are recognized as exempt party-in-interest transactions under ERISA.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their account balances.

7. TAX STATUS

The Plan utilizes a pre-approved profit sharing plan sponsored by FIS Business Systems LLC. The pre-approved profit sharing plan obtained a determination letter dated June 30, 2020 from the IRS, which states that the Plan, as designed, complied with applicable requirements of the Internal Revenue Code (IRC) and accordingly, was exempt from federal income tax. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any taxing periods in progress.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

9. REGULATORY CHANGES

SECURE Act

The Setting Every Community Up for Retirement Enhancement (SECURE) Act was signed into law on December 20, 2019, though the changes became effective beginning in 2020 and subsequent periods.

The Plan was amended effective January 1, 2022, to adopt the applicable provisions of the SECURE Act.

CARES Act

During 2020, the COVID-19 virus spread to the United States of America. Effective March 2020, the World Health Organization declared the virus outbreak a pandemic. COVID-19 led to significant volatility in financial markets and had a significant impact on national and local economies as a whole.

In response to the pandemic, the Federal Government signed into law the Coronavirus Aid, Relief, and Economic Security (CARES) Act. The CARES Act provided economic relief in various forms, including retirement plan provisions that allowed for coronavirus-related distributions and loans, and waived required minimum distribution requirements for the calendar year 2020.

The Plan was amended in December 2020 to adopt the applicable provisions of the CARES Act.
