Biomeme Severance Policy

Biomeme offers benefits associated with employment separation in the following instances, downsizing, job elimination, change of control, layoffs and other instances the company deems appropriate.

The following benefit schedule for these instances is as follows; there will be a minimum benefit of two weeks of pay. Part-time employees will be eligible for the same benefit at a rate of 20 hours per week schedule. Each year beyond 2 years of employment Biomeme will provide an additional week of severance. Example below:
