## **Independent Auditors' Report**

To the Plan Administrator of

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audit of the financial statements of Spin-off Termination Plan for Arranta Bio MA, LLC (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of October 31, 2022 (in liquidation) and the related statement of changes in net assets available for benefits for the period from April 7, 2022 (date of inception) to October 31, 2022 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of October 31, 2022 and for the period from April 7, 2022 (date of inception) to October 31, 2022, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### **Opinion on the Financial Statements**

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.



Our opinion is not modified with respect to that matter.

## Notes to Financial Statements

October 31, 2022 (In Liquidation)

### (1) **Description of Plan**

The following description of the Spin-off Termination Plan for Arranta Bio MA, LLC (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

#### (a) **General**

The Plan is a spin-off from the TriNet 401(k) Plan (“TriNet Plan”). All assets were transferred from the TriNet Plan on April 7, 2022, the inception date and the date on which the Plan adopted the Transamerica Retirement Solutions, LLC (“TRS”) Non-Standardized Defined Contribution Pre-Approved Plan Document. Effective April 7, 2022, the Plan was terminated, with all participant balances being 100% vested immediately. Distribution of account balances to participants occurred as soon as was administratively feasible following the termination of the Plan.

#### (b) **Administration of Plan Assets**

The Plan is a defined contribution plan for employees of Arranta Bio MA, LLC (“Plan Sponsor” or “Company”). The Plan operates in compliance with the regulations under the Internal Revenue Code of 1986 and was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Upon termination of the Plan on April 7, 2022, the Plan was frozen. No contributions were remitted to the Plan from the inception date to termination date.

#### (c) **Eligibility**

The Plan is frozen, and no new employees are permitted to participate in the Plan.

#### (d) **Contributions**

Prior to termination of the Plan, participants could elect to contribute a portion of their compensation on a pretax or Roth basis, up to limits allowed by the Internal Revenue Service. Also prior to termination, the employer could elect to make a discretionary matching contribution of 100% of the first 5% deferred by participants, not to exceed 5%.

#### (e) **Participant Accounts**

Participant accounts are credited with an allocation of plan earnings and expenses. The benefit to which a participant is entitled is equal to the vested value of their account.

#### (1) Description of Plan - Continued

##### (f) Vesting

As a result of the termination of the Plan, all participants were 100% vested in their account balances.

##### (g) Investment Options

The Plan offered investments in pooled separate accounts and a general account obligation. Contributions made by the Plan Sponsor are allocated based on the funds selected by the participants for the employee contributions. Participants are allowed to execute investment transfers between the Plan's investment options on a daily basis.

##### (h) Payment of Benefits

As a result of the termination of the Plan, all participants received full withdrawals of their account balances.

In-service and hardship withdrawals were not permitted under the Plan.

##### (i) Forfeited Accounts

There were no forfeited non-vested account balances from the TriNet Plan available to be used to reduce administrative expenses or to be reallocated to participants during the period. No new forfeitures were available for use subsequent to the plan termination date, as all participants became 100% vested as a result of the termination.

##### (j) Notes Receivable from Participants

The Plan does not allow loan withdrawals. All previous loans issued under the TriNet Plan and transferred into the Plan were distributed as part of withdrawals or were transferred out of the Plan to another qualified 401(k) at the participant's request.

#### (2) Summary of Significant Accounting Policies

##### (a) Basis of Presentation

Effective April 7, 2022, with the termination of the Plan (see Note 1(a)), the financial statements of the Plan are presented on the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America.

#### (2) Summary of Significant Accounting Policies - Continued

##### (b) Investment Valuation and Income Recognition

Investments in pooled separate accounts are stated at fair value as determined by Transamerica Financial Life Insurance Company (“TFLIC”). Such fair values are based on quotations from active markets, such as national security exchanges or brokerage firms, on yields currently available on comparable securities and the Plan’s participation units in the account.

The pooled separate accounts are credited with earnings in the underlying investments, net of investment management expenses. Changes in the fair value of investments in pooled separate accounts and gains or losses on disposal of these investments are reported in the statement of changes in net assets available for benefits as net depreciation in fair value of investments.

Investments in the general account obligation allow participants to invest money in a general account of TFLIC which earns interest. The Sponsor has determined, based on recommendations from TFLIC, that this investment is fully-benefit responsive. Participant contributions are commingled with TFLIC’s other assets and TFLIC assumes the risk of principal and accrued interest. An effective annual rate of interest is established before the first day of each month.

Interest is credited to the general account obligation daily based on its daily balance, at a rate of interest that is the daily equivalent of the effective annual rate of interest applicable for each month. The general account obligation is reported at contract value as of October 31, 2022.

Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

##### (c) Administrative Expenses

Management fees and operating expenses are paid out of the Plan unless paid by the Company and the Company does not elect to be reimbursed by the Plan as permitted by the plan agreement.

Participants are charged a quarterly recordkeeping fee and a contract asset charge calculated monthly on the combined asset balance of all contract accounts in the Plan as of the 15<sup>th</sup> day of each month. In addition, there are expense ratios and other costs associated with each investment option. There are also fees that relate to requesting loans and distributions.

##### (d) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and the related changes therein. Actual results could differ from those estimates.

#### (3) **Income Tax Status**

The Plan adopted the TRS Non-Standardized Defined Contribution Pre-Approved Plan Document effective April 7, 2022, which obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Service. The plan document has been amended since receiving the opinion letter. However, the Company and the Plan's tax counsel believe that the plan document is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of October 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### (4) **Party-in-Interest Transactions**

Certain of the Plan's investments were managed by TFLIC. While this activity qualifies as party-in-interest activity as defined in Section 3(14) of ERISA, it is expressly exempted from the prohibited transaction rules. Participant loan transactions are considered to be party-in-interest transactions, because they are transacted with plan participants.

During 2022, the Plan paid approximately \$12,000 in administrative expenses to TFLIC and the previous plan sponsor and as such are considered party-in-interest transactions.

#### (5) **Risks and Uncertainties**

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statement of net assets available for benefits.
