To the Plan Administrator of the  
Solidifi Title & Closing, LLC 401(k) Plan:

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the Solidifi Title & Closing, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statements of Net Assets Available for Plan Benefits as of March 31, 2022 and December 31, 2021, and the related Statement of Changes in Net Assets Available for Plan Benefits for the period from January 1, 2022 to March 31, 2022, and the related notes to the financial statements.

### NOTES TO THE FINANCIAL STATEMENTS

Period from January 1, 2022 to March 31, 2022 and Year Ended December 31, 2021

#### 1. Description of the Plan

The following description of the Solidifi Title & Closing, LLC 401(k) Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

##### *General*

The Plan is a participant-directed defined contribution plan covering all employees of Solidifi Title & Closing, LLC; Linear Title, LLC; FirstLine Title, LLC (formerly Linear, LLC) and all employees of the five members of the controlled group, Solidifi Title Company of California; Solidifi Title Agency of Utah, LLC; Solidifi Title & Closing of Alabama, LLC; Solidifi Title Agency, Ltd.; and Performance Title, LLC (collectively, the Employer) who have attained the age of 21 and have completed six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Employer is also the Plan Administrator. As Plan Administrator, the Employer has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. Four employees of the Employer serve as trustees of the Plan.

In 2021, the Board of Directors approved the merger of the Plan into the Solidifi 401(k) Plan. All assets of the Plan were transferred on March 31, 2022. See Note 9 for additional details.

##### *Contributions*

Participants may elect to contribute 100% of their annual pre-tax eligible compensation to the Plan, so long as those contributions do not exceed annual limitations set by the Internal Revenue Code (IRC). Participants may designate some or all of their elective deferrals as Roth 401(k) deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers).

The Employer makes safe harbor matching contributions of 100% of the first 3% of eligible earnings that a participant contributes to the Plan and 50% of the next 2% of eligible earnings that a participant contributes to the Plan. Additional Employer discretionary profit-sharing contributions are determined on an annual basis by the Employer's Board of Directors. To be eligible for the discretionary profit-sharing contribution, participants must complete at least 1,000 hours of service in the Plan year and must be employed on the last day of the Plan year. Discretionary profit-sharing contributions are allocated based on a participant's compensation as a percentage of all eligible participants' compensation. No Employer discretionary contributions were made during the period from January 1, 2022 to March 31, 2022.

***Participant Accounts***

Each participant's account is credited with the participant's contribution and their allocations of the Employer's contributions, Plan earnings and losses and investment expenses. Allocations are based on the participant's compensation or individual participant account balances, as defined in the agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions, rollover contributions, Employer safe harbor matching contributions, Employer discretionary contributions, and actual earnings thereon.

***Participant Notes Receivable***

Participants may borrow from their account a minimum of \$1,000 and up to a maximum generally equal to the lesser of \$50,000 or 50% of their vested account balance. Terms range from one to five years (or up to 10 years for the purchase of a primary residence). Notes are secured by the vested balance in the participant's account and bear interest at a rate which is commensurate with local prevailing rates or determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions. Participants may only have one note outstanding at any given time.

***Payment of Benefits***

Upon retirement, death, disability or termination of service, a participant or beneficiary may elect to receive a lump-sum amount or installment payments equal to the value of his or her vested interest in their account. The Plan also provides for mandatory distributions to participants upon reaching age 70½. Upon termination of employment for reasons other than death, disability, or retirement, a participant's vested balance that is \$1,000 or less upon termination will be distributed to the participant in a lump-sum distribution. If a participant's vested balance exceeds \$1,000 and is equal to or less than \$5,000, the amount will be rolled over to an individual retirement account designated by the Employer, unless otherwise directed by the participant.

Upon reaching age 59½, participants may elect to withdraw all or a portion of their account balance while still employed by the Employer.

***Hardship Withdrawals***

A hardship withdrawal may be authorized by the Employer in an amount up to 100% of the vested portion of participant's elective deferrals, rollovers, Employer matching contributions and Employer discretionary contributions.

***Forfeitures***

As of March 31, 2022, there were no forfeited non-vested accounts. As of December 31, 2021, forfeited non-vested accounts totaled \$1,000. These accounts may be used to reduce future Employer contributions, pay administrative expenses or be reallocated to participants. Forfeited non-vested accounts totaling \$1,000 were included in the transfer of assets to the Solidifi 401(k) Plan completed on March 31, 2022 (Note 9).

***Plan Termination***

The Employer reserves the right to amend the Plan at any time and in any manner that it deems advisable, provided that no amendment shall have the effect of diverting Plan assets for purposes other than for the exclusive benefit of the Plan participants, and any Plan termination would be subject to the provisions of ERISA. On March 31, 2022, the Plan was merged into the Solidifi 401(k) Plan, another plan under common ownership of the Employer (Note 9).

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

***Valuation of Investments and Income Recognition***

The Plan's investments are reported at fair value, except for amounts allocated to the insurance company general account investment which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 3). Contract value represents investments at cost plus accrued interest income less amounts withdrawn to pay benefits. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Participant Notes Receivable***

Participant notes receivable are measured at their unpaid principal balances plus any accrued but unpaid interest and are secured by the balance in the respective participant's account. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income on participant notes receivable is recorded when it is earned. A receivable is considered past due if payment has not been received within stated terms.

Delinquent notes receivable from participants are reclassified as distributions based on the terms of the Plan document. No allowance for credit losses has been recorded as of March 31, 2022 and December 31, 2021.

***Contributions***

Participant and Employer matching contributions are recorded bi-weekly when the Employer remits the contributions for investment into the Plan. Employer discretionary contributions are made at the end of each year, if applicable.

***Payment of Benefits***

Benefits are recorded when paid to participants or their designated beneficiaries.

***Administrative Expenses***

Certain expenses incurred in the administration of the Plan are paid directly by the Employer, unless the Employer directs that such expenses shall be paid by the Plan. Expenses that are paid directly by the Employer are excluded from these financial statements. Participant notes receivable set-up and maintenance fees are paid directly by the participants through a reduction in their account and are included in administrative expenses.

Investment management and recordkeeping fees, if applicable, are paid by the Plan through revenue sharing as a reduction of investment income (net appreciation or depreciation) from the related investment fund.

***Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets available for plan benefits. Accordingly, actual results may differ from those estimates.

***Risks and Uncertainties***

The Plan provides for various investment options with a variety of investment objectives. Investment securities are exposed to various risks such as interest rate, market and credit risks.

***Financial Instruments with a Concentration of Credit Risk***

For the period January 1, 2021 to March 31, 2022, the Plan's investments were held by a single custodian. The Plan's exposure to credit risk is associated with the outside entity's non-performance of their fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

***Subsequent Events***

Management has evaluated subsequent events through January 5, 2023, which is the date these financial statements were available to be issued.

**3. Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions that market participants would use in pricing the asset.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

*Money Market Funds:* The carrying amount of the money market fund is deemed to be valued at deposit amount plus accrued interest, as determined according to stated terms.

**NOTES TO THE FINANCIAL STATEMENTS**

**Period from January 1, 2022 to March 31, 2022 and Year Ended December 31, 2021**

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

As of December 31, 2021, the Plan's investments in money market funds and mutual funds are reported at level 1 within the fair value hierarchy. As a result of the plan merger, there are no investment balances at March 31, 2022 (Note 9).

**4. Investment Contract with Insurance Company**

The Plan has entered into an investment contract (Fixed Account) with Voya Retirement Insurance and Annuity Company (Voya). Amounts held in connection with this contract may be held in Voya's general account or separate accounts which invest in mutual funds advised by Voya, mutual funds sub-advised by third parties, mutual funds managed by external mutual fund companies or invested directly in securities.

Contributions allocated to the Fixed Account are invested in the general account of, and are guaranteed by, Voya. All other contributions allocated to any investment fund become part of separate accounts that are maintained separately from the general assets of Voya. The value of these contracts included in the financial statements, as reported to the Plan by Voya, is equal to the sum of the contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses.

The contract value of funds allocated to the traditional general account investment with Voya at December 31, 2021 was \$12,232. As a result of the plan merger, there was no balance in this investment at March 31, 2022 (Note 9). The crediting interest rate was 1.00% at March 31, 2022 and December 31, 2021. Withdrawals from this investment for other than the payment of benefits may be subject to a market value adjustment and a surrender charge and the ability to move funds out of this investment may be restricted by Voya.

The guarantee of values provided for investments made with Voya under the Plan's investment contract are based on the financial strength and claims-paying ability of Voya.

**5. Income Tax Status**

The Plan has been designed using a volume submitter plan document designed by The Angell Pension Group, Inc. The Angell Pension Group, Inc. received an advisory letter dated September 30, 2014, in which the Internal Revenue Service (IRS) stated that the Volume Submitter Plan satisfies the applicable requirements of the IRC. The Plan has been amended since receiving the advisory letter in order to comply with the latest applicable tax laws and regulations. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of March 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax years in progress.

**6. Summary of Financial Data Certified by the Custodian**

The following is a summary of financial information and data certified by Voya, the custodian:

Statements of Net Assets Available for Plan Benefits at March 31, 2022 and December 31, 2021;and

Investment income, interest income from participant notes receivable and net depreciation in fair value of investments on the Statement of Changes in Net Assets Available for Plan Benefits for the period from January 1, 2022 to March 31, 2022.

**7. Differences from Form 5500**

Differences between the Annual Return/Report of Employee Benefit Plan, Form 5500, and these financial statements are a result of different classifications between line items. Total Plan assets are in agreement.

**8. Related Party Transactions and Party-in-Interest Transactions**

Plan investments are held and managed by Voya, the custodian of the Plan. Therefore, these transactions qualify as party-in-interest transactions. The Plan made aggregate payments of \$18,036 to the custodian, third-party administrator and independent investment advisor during the period from January 1, 2022 to March 31, 2022. In addition, participant notes receivable qualify as party-in-interest transactions. Four employees of the Employer serve as trustees of the Plan.

**9. Plan Merger**

The Plan Administrator adopted a resolution to merge the Plan into the Solidifi 401(k) Plan on March 31, 2022. As a result, all participant balances were transferred to the Solidifi 401(k) Plan on that date. The assets transferred from the Plan totaled \$10,664,969, including participant notes receivable of \$108,768. On March 31, 2022, the Plan was formally terminated.

**10. Non-exempt Transactions**

During 2021, the Employer failed to remit participant contributions of \$3,300 and loan repayments of \$1,921 to the Plan on a timely basis as prescribed in the applicable Department of Labor Regulations 29 CFR 2510.3-102. Defined contribution plans must remit employee contributions to the Plan as soon as they can be reasonably segregated from the Employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld or received by the Employer. The Employer remitted all participant contributions due to the Plan, along with lost earnings associated with these late remittances, during 2022.
