We have performed audits of the accompanying financial statements of the Strive Consulting, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (in liquidation) as of July 26, 2022 and December 31, 2021, and the related statement of changes in net assets in liquidation available for benefits for the period ended July 26, 2022, and the related notes to the financial statements.

All Plan participants were fully vested, and the plan sponsor distributed all Plan assets as of July 26, 2022. Our opinion is not modified with respect to this matter.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Strive Consulting, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan was terminated effective December 8, 2021. Accordingly, the descriptions below represent the provisions of the Plan prior to termination. See Note 8 for further information regarding the Plan termination.

General

The Plan was a contributory, defined contribution plan covering employees of Strive Consulting, LLC. Union employees, non-resident aliens, and leased employees were not eligible for the Plan. To be eligible for Company discretionary contributions, an employee must have completed one year with 1,000 hours of continuous service and have also attained 21 years of age. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may have contributed up to 90% of their annual compensation up to the maximum allowable limits of Code Section 401(k). Each year, the Company had the option to make a discretionary contribution which was not limited to its current or accumulated net profit. Participant and employer contributions were ceased upon the termination of the Plan.

The Company also had the option to make an employer "safe harbor" matching contribution within the meaning of Section 401(k)(12) of the Internal Revenue Code based on an annual election. This "safe harbor" matching contribution was equal to 100% of the participants' contributions not exceeding 3% of eligible compensation and 50% of the participants' contributions exceeding 3% but not exceeding 5% of eligible compensation.

Participant Accounts

Each participant's self-directed 401(k) account was credited with the participant's contributions and earnings on the participant's contributions, and was charged with plan expenses. Each participant had a separate self-directed 401(k) account for employer matching and employer discretionary contributions, which consisted of the Company's contributions and earnings on the Company's contributions, and which was charged with plan expenses.

Vesting

Participants were immediately vested in their voluntary contributions and employer "safe harbor" matching contributions plus actual earnings thereon. Vesting in the Company discretionary contributions portion of their accounts plus earnings thereon was based on years of continuous service. A participant was 100% vested after six years of credited service.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Description of Investment Options

The Plan's assets were held in a trust administered by John Hancock Life Insurance Company (U.S.A.). Participants could elect to have their account contributions invested in one or a combination of investment options provided by the Plan. The investment options consisted of various pooled separate accounts as selected by the Plan Trustees.

Payment of Benefits and Distributions

On termination of service due to death, disability, retirement, or other reasons, a participant would receive an amount equal to the value of the participant's vested interest in a lump-sum payment or in a series of partial payments. In addition, the Plan provided for in-service withdrawals under certain circumstances.

Notes Receivable from Participants

The Plan contained provisions which allowed for loans to participants, subject to certain restrictions. The maximum loan amount was the lesser of one half of the vested balance or \$50,000 reduced by the highest outstanding loan balance in the account during the prior 12 month period. Up to 50 percent of the vested balance may have been used as collateral for the loan. These loans, which had a maximum term of five years (longer, if used to acquire a participant's principal residence), were to be repaid through regular payroll withholdings. The interest rate charged for loans from the Plan was established by the Plan Trustees.

Administrative Expenses

Certain administrative expenses have been paid by the Company. Administrative expenses paid by the Plan included investment advisory and management fees.

Forfeited Accounts

Forfeited non-vested accounts totaled \$-0- and \$5 at July 26, 2022 and December 31, 2021, respectively. These forfeitures could be used to pay administrative expenses or reduce employer contributions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Administration

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Basis of Accounting

As discussed in Note 8, the Plan was terminated effective December 8, 2021. As a result, the financial statements of the Plan were prepared under the liquidation basis of accounting for the periods ended July 26, 2022 and December 31, 2021. Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process, and liabilities are measured using the accrual basis of accounting and include any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balance plus any accrued but unpaid interest.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Trustees to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and that also affect revenues and expenses during the reporting period. Actual results could differ from those estimates.

Date of Management's Review

For the current reporting period, subsequent events were evaluated through January 5, 2023, which represents the date the financial statements were available to be issued.

NOTE 3 - INVESTMENTS

The financial information relating to the Plan's investments is included in the accompanying financial statements based on information provided by the custodian. John Hancock Life Insurance Company (U.S.A.) was the custodian of the Plan's investments at July 26, 2022 and December 31, 2021. All investments were participant directed utilizing the investment options provided by the Plan.

NOTE 5 - FAIR VALUE MEASUREMENTS

The Fair Value Measurements and Disclosure Topic of the Financial Accounting Standards Board Accounting Standards Codification establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at July 26, 2022 and December 31, 2021.

Pooled separate accounts: Valued based on the latest quoted market prices of the underlying securities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 - TAX STATUS

The volume submitter plan sponsor obtained an opinion letter dated June 30, 2020, in which the IRS stated that the restated volume submitter plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan Trustees timely adopted the restated volume submitter plan. The Plan Trustees believe that the Plan is being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor or the Internal Revenue Service. The Plan Trustees have analyzed the tax positions taken by the Plan, and have concluded that as of July 26, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Trustees believe the Plan is no longer subject to income tax examinations for years prior to 2019.

NOTE 7 - PARTY IN INTEREST TRANSACTIONS

Plan investments included pooled separate accounts managed by John Hancock Life Insurance Company (U.S.A.). John Hancock Life Insurance Company (U.S.A.) is the custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the custodian are included as a reduction of the return earned on the pooled separate accounts.

NOTE 8 - TERMINATION OF THE PLAN

On December 8, 2021, the plan sponsor adopted a resolution to freeze and terminate the Plan in connection with the sale of the Company. In accordance with accounting principles generally accepted in the United States of America, the Plan changed its basis of accounting from the ongoing basis to the liquidation basis for the periods ended July 26, 2022 and December 31, 2021. All participants were fully vested in their account balances, and the plan sponsor liquidated all Plan assets through distributions to participants with account balances by July 26, 2022.
