Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

We have performed an audit of the financial statements of the Bartley Healthcare, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of April 29, 2022 and December 31, 2021, and the related statements of changes in net assets available for benefits for the period and year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the period ended April 29, 2022, and as of December 31, 2021, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Note 1 - Summary of Plan Provisions

The following brief description of the Bartley Healthcare, Inc. 401(k) Plan (the "Plan"), is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

a. Plan Termination

The Plan Sponsor elected to terminate the Plan as of April 29, 2022. As of the date of termination, all participants with balances in the Plan became 100% vested in their accounts. All assets were distributed as of the Plan termination date. In relation to the Plan termination, the Plan was frozen as of January 15, 2022. Employee pre-tax and Roth contributions and employer non-elective safe harbor and matching contributions were ceased. Distributions were still allowed.

b. General

The Plan is a defined contribution plan, covering all eligible employees of Bartley Healthcare, Inc. and related entities (the "Company"). Employees are eligible to participate in the Plan when they have reached the age of 21 and have been employed for 12 consecutive months during which the employee completed at least 1,000 hours of service. To share in the discretionary employer matching contribution, eligible employees must complete 1,000 hours of service during the Plan year and be employed on the last day of the plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Company includes the following entities which are related through common ownership: Bartley Healthcare Management, LLC, Bartley Assisted Living, LLC, and Bartley Associates, LLC.

The Plan assets are currently held by Capital Bank and Trust Company, Custodian of the Plan. Company contributions, participant elective deferrals, and participant accounts are also held by the Custodian, who invests cash received and income from investments based on written instructions from the Company and participants and makes distributions to participants. The Plan's Trustee is responsible for oversight of the Plan and for determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

c. Contributions

Pre-tax employee contributions are made pursuant to salary deferral agreements. Each year, participants may contribute a percentage of their pre-tax annual compensation, subject to certain limitations as defined by the Plan and the Internal Revenue Code ("IRC"). The maximum participant deferral for the period ended April 29, 2022 and year ended December 31, 2021 was \$20,500 and \$19,500, respectively. Participants age 50 and over are also eligible to make catch-up contributions. Participants may also contribute rollover amounts representing distributions from other qualified plans, providing they are made within 60 days of receipt of such amounts by an employee.

The Company provides for a discretionary match equal to 25% of participant deferrals up to \$1,500 for the year ended December 31, 2021. During the period ended April 29, 2022 and year ended December 31, 2021, there were no discretionary matching contributions.

d. Participant Accounts

Each participant's account is credited with the participant's contribution as well as allocations of (a) the Company's discretionary match contributions, and (b) the Plan's investment earnings (losses), net of investment and administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

e. Vesting

Participants are 100% vested immediately in all employee contributions made to the Plan.

Vesting in the Company's discretionary match contribution is based on years of continuous service. A participant is 100% vested upon: (1) disability; (2) death; (3) normal retirement at age 65; or (4) termination of the Plan. If a participant's employment with the Company is terminated before age 65 for any reason other than disability or death, the participant shall be entitled to an amount equal to the "vested percentage" of his or her account balance. A participant shall have a vested and nonforfeitable interest in the employer's discretionary contribution portion of his or her account balance determined by the number of years of credited service as follows:

f. Payment of Benefits

On termination of service, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account or elect to rollover funds into an IRA or other retirement account. Annuities are not allowed by the Plan. Prior to termination, a participant may withdraw their pretax contributions in the event of undue financial hardship. The Plan also provides for in-service distributions for participants who have attained age 59½.

g. Forfeited Accounts

Forfeited non-vested accounts, which can be used to reduce the employer matching contribution of the Plan, totaled \$-0- at April 29, 2022 and 2021. The employer matching contribution for 2022 and 2021 was reduced by \$-0- from forfeited non-vested accounts subsequent to year end.

Note 2 - Summary of Significant Accounting Policies

a. Basis of Accounting and Financial Statement Presentation

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") for defined contribution plans.

b. Estimates

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting year. Actual results could differ from those estimates.

c. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustee determines the Plan's valuation policies utilizing information provided by the investment advisor.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

d. Notes Receivable from Participants

Notes receivable from participants are not permitted by the Plan.

e. Payment of Benefits

Benefits are recorded when paid.

f. Administrative Expenses

Certain administrative expenses of the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

g. Subsequent Events

The Plan has evaluated subsequent events for potential recognition or disclosure through December 20, 2022, the date the financial statements were available to be issued.

Note 4 - Investments and Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at April 29, 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5 - Related Party and Party-In-Interest Transactions

The Company paid expenses in connection with the administration of the Plan totaling \$-0- and \$39,580 for the period ended April 29, 2022 and year ended December 31, 2021, respectively.

Certain administrative functions are performed by employees of the Company who do not receive compensation for such functions.

Certain Plan investments are managed by Capital Bank and Trust Company, the Custodian of the Plan. In addition, indirect fees were paid by the Plan for investment management and advisory services for the period ended April 29, 2022 and year ended December 31, 2021.

Note 6 - Tax Status

The IRS has ruled in an advisory letter dated March 31, 2014 that the Prototype Non-Standardized Profit-Sharing Plan with CODA adopted by the Plan constitutes a qualified plan under Section 401(a) of the IRC and is, therefore, exempt from federal income taxes under the provisions of Section 501(a).

The Plan's management evaluates tax positions taken by the Plan and recognizes a tax liability or asset if an uncertain tax position was taken and it is more-likely-than-not that the tax position would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions during the three-year period prior to the period covered by these financial statements.

Note 7 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit.
