Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of June 30, 2022 and December 31, 2021, and for the period ended June 30, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

Basis for Opinion on the Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Emphasis of Matter—Plan Termination

As discussed in Note 1 to the financial statements, the Board of Directors of W.E. Blain & Sons, Inc., the Plan's sponsor, voted on December 1, 2021, to terminate the Plan, and the Plan commenced liquidation shortly thereafter. As a result, the Plan has changed its basis of accounting for periods subsequent to December 1, 2021, from the going-concern basis to a liquidation basis. Our opinion is not modified with respect to this matter.

Note 1. Description of the Plan

The following description of The Blain Companies 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of W.E. Blain & Sons, Inc. (the "Sponsor") and certain affiliates who have completed one year of service, are age 21 or older and have been credited with 1,000 hours of service within a 12-month period. The Plan is subject to the provisions of the ERISA.

Plan Termination

On December 1, 2021 the Sponsor's Board of Directors adopted resolutions to terminate the Plan effective December 1, 2021 ("Termination Date"). As a result, management determined liquidation was imminent as of December 1, 2021. As of June 30, 2022, the Plan completed liquidation and all assets were distributed to plan participants.

Contributions

Participants may contribute any amount up to 100 percent of their compensation subject to regulatory limitations, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Sponsor may make a discretionary match to each separately designated employee group equal to a uniform percentage of base compensation that each eligible participant of that employee group contributes to the Plan. For the period ended June 30, 2022, the Sponsor elected not to make discretionary matching contributions to highly compensated employees or non-highly compensated employees. Also, the Sponsor may make a profit-sharing contribution at the discretion of the Sponsor's Board of Directors. For the period ended June 30, 2022, the Sponsor elected not to contribute a profit sharing contribution.

Participants may also transfer to the Plan certain vested account balances from other qualified benefit plans, subject to regulatory requirements. Participants direct the investment of contributions into various investment options by the Plan, which they may change daily.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Sponsor's matching contributions, (b) Plan earnings and losses and (c) the Sponsor's profit-sharing contributions and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant compensation or account balances as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100 percent vested in their entire account balance at all times as defined by the Plan.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum payment, life annuity or monthly or annual installments. For termination of service due to other reasons, a participant may receive the value in his or her account at the time of termination or the occurrence of the normal retirement date as defined in the Plan. After attaining age 59 1/2, a participant may elect to receive an in-service distribution for all or a portion of their vested balance. Hardship distributions are also available from a participant's account subject to regulatory requirements.

Unallocated Assets

Unallocated assets are comprised of administrative expenses originally paid by the Plan sponsor that are ultimately refunded to the Plan. Unallocated assets can be used to reduce expenses paid by the Plan in the future. These unallocated assets are included in the statements of net assets available for benefits as investments. Unallocated assets totaled \$-0- and \$22,861 at June 30, 2022 and December 31, 2021, respectively. For the period ended June 30, 2022, unallocated assets of \$31,571 were allocated to participant accounts prior to liquidation.

Note 2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared using the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at liquidation value. For all investments, fair value approximates the amount the Plan expects to collect at liquidation. As of June 30, 2022, there were no investments remaining in the Plan.

See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a settlement-date basis. Interest income and dividends are recorded on the liquidation basis, including amounts expected to be earned through the final distribution of Plan assets. Net depreciation of investments includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Payment of Benefits

Distributions pursuant to the Plan termination are paid at the participants' election by (a) cash distribution of the present value of the participant's account; or (b) rollover distribution to an eligible retirement plan.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Administrative expenses of the Plan, to the extent that the Sponsor does not pay such expenses, are paid by the Plan.

Note 3. Information Certified and Provided by Capital Bank and Trust Company

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at June 30, 2022 and December 31, 2021 and net depreciation of investments and interest and dividend income for the period ended June 30, 2022, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Capital Bank and Trust Company (the "Capital Bank" or "American Funds").

Note 4. Fair Value Measurements

Financial Accounting Standards Board ("FASB") ASC Topic 820, *Fair Value Measurement* ("ASC 820") establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability,
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. As discussed in Note 2, fair value approximates the amount the Plan expects to collect at liquidation.

Mutual funds: Valued at the daily closing price per share as reported by the fund at year end. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1).

Collective investment trust: Valued based on NAV of units of the common collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Related Party Transactions

Certain Plan investments are managed by Capital Bank. Capital Bank is the current custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees totaling \$38 were paid to Capital Bank by the Plan for the period ended June 30, 2022.

Malcolm Thompson and Associates is the trustee and was paid fees by Capital Bank for plan management services of \$50 for the period ended June 30, 2022. As the Plan's trustee, these transactions qualify as exempt party-in-interest transactions.

Note 6. Income Tax Status

The Sponsor has adopted a volume submitter plan whose practitioner obtained its latest determination letter on September 30, 2014, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The volume submitter plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and the plan termination does not adversely affect the qualification of the Plan. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 7. Subsequent Events

The Plan has evaluated subsequent events through December 30, 2022, the date these financial statements were available to be issued.
