### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We were engaged to perform audits of the financial statements of Lake Hospital System, Inc. 403(b) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of July 15, 2022 and December 31, 2021 and the related statement of changes in net assets available for benefits for the period from January 1, 2022 through July 15, 2022 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of July 15, 2022 and December 31, 2021 and for the period from January 1, 2022 through July 15, 2022 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Disclaimer of Opinion**

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matter described in the *Basis for Disclaimer of Opinion* section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

### **Basis for Disclaimer of Opinion**

As described in Note 4, the Plan has excluded from investments in the accompanying statement of net assets available for benefits certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the DOL Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded from the accompanying statement of changes in net assets available for benefits. The amount of these excluded annuity and custodial accounts and the related income and distributions are not determinable. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the accompanying financial statements. The Plan has not maintained sufficient accounting records and supporting documents relating to these annuity and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficiently to determine the extent to which the financial statements may have been affected by these conditions.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

### Note 1 - Plan Description

The following description of Lake Hospital System, Inc. 403(b) Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering substantially all employees of Lake Hospital System, Inc. (d.b.a. Lake Health) (the "System"). Employees became participants in the elective deferral portion of the Plan on their first day of employment with the System. Employees were eligible for the System's discretionary matching and nonelective contributions after they completed one year of service. One year of service was defined as the 12-month plan year that was coincidental with a calendar year. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective April 16, 2021, the System executed a member substitution agreement where University Hospitals acquired the System. Subsequent to the agreement and effective December 31, 2021, the Plan was frozen to new participants.

The Plan merged into the University Hospitals Health System, Inc. 403(b) Matched Retirement Savings Plan on July 15, 2022.

#### **Contributions**

Each year, participants could contribute up to the maximum percentage of pretax annual compensation, as defined by the Plan, including Roth elective deferrals. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants directed the investment of their contributions into various investment options offered by the Plan. Participants who attained age 50 before the end of the plan year were eligible to contribute additional catch-up contributions. The System could contribute, at its discretion, a matching contribution equal to a uniform percentage of the amount of a participant's salary reduction, and the percentage was determined each year by the System. Effective December 31, 2021, the Plan was frozen to new participants, and there were no contributions made to the Plan during 2022. Contributions were subject to limitations contained in Section 402(g) of the Internal Revenue Code.

#### **Participant Accounts**

American United Life Insurance Company (AUL) maintained individual accounts for each participant for the deposit of contributions and earnings thereon. Earnings on plan assets were distributed based upon the participants' pro rata share of the total account balances.

Allocations were based on participants' compensation or account balances, as defined in the plan agreement. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

#### **Vesting**

Participants were immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Vesting in the System's contribution portion of their accounts, plus actual earnings thereon, was based on years of continuous service. A participant was 100 percent vested after six years of credited service, as defined by the Plan. Employees hired prior to January 1, 2004 who became participants were 100 percent vested after two years of credited service, as defined by the Plan.

#### **Participant Notes Receivable**

Participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. The notes receivable were secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates determined periodically by the System. Principal and interest were paid ratably through biweekly payroll deductions.

**Note 1 - Plan Description (Continued)**

***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to pay plan expenses and to reduce future employer contributions.

***Benefit Payments***

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or in annual installments over a 10-year period. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The System may distribute to participants up to 100 percent of their elective deferral account balances in the event of a hardship if participants satisfy certain requirements that demonstrate immediate and heavy financial need.

***Party-in-interest Transactions***

Certain plan assets were in investment funds managed by American United Life Insurance Company or its affiliates. AUL was the custodian of the Plan; therefore, these transactions qualified as party-in-interest transactions, as defined under ERISA guidelines.

***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balance.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation***

The Plan's investments are stated at fair value except as noted below. The fully benefit-responsive unallocated contract is valued at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

The pooled separate accounts are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying assets.

***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

***Benefit Payments***

Benefits are recorded when paid.

***Administrative Expenses***

Various administrative costs are paid by the System or the Plan, at the discretion of the System.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including December 14, 2022, which is the date the financial statements were available to be issued.

**Note 3 - Unaudited Information**

American United Life Insurance Company (the "Custodian") held certain of the Plan's investments and participant notes receivable and executed certain related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and were based solely on information certified by the Custodian.

The Plan excluded certain assets from the statement of net assets available for benefits at July 15, 2022 and December 31, 2021 (see Note 4).

**Note 4 - Excluded Investments**

The Plan has excluded from investments in the accompanying statement of net assets available for benefits as of July 15, 2022 and December 31, 2021 certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded in the accompanying statement of changes in net assets available for benefits for the period from January 1, 2022 through July 15, 2022. The amount of these excluded annuity and custodial accounts and the related income and distributions was not determinable. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the accompanying financial statements.

**Note 5 - Tax Status**

The Plan, as adopted, was a volume submitter plan, which does not require an application for a determination letter from the Internal Revenue Service (IRS). The volume submitter plan received a favorable notification letter from the IRS dated November 22, 2017. The Plan had not individually sought its own determination letter.

**Note 6 - Unallocated Contract**

The Plan had a benefit-responsive unallocated contract with AUL. AUL maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. There were no reserves against contract value for credit risk of the contract issuer or otherwise. The interest crediting rate was based on a formula agreed upon with the issuer and had a 4 percent minimum guarantee.

**Note 6 - Unallocated Contract (Continued)**

Interest rates were established and declared for new contributions received in a calendar quarter. The rate was based on the return AUL expected on new investments made by it and held with the AUL general account. When establishing crediting rates for these contracts, AUL considered past general account investments, adjusted for portfolio turnover and withdrawals for benefit payments. The crediting rate always equaled or exceeded the contractually guaranteed rate.

Certain events limit the ability of the Plan to transact at contract value with the insurance company. Such events included the following: (i) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provision, (iii) bankruptcy of the plan sponsor or other plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator believed that the occurrence of any such events, other than the merger described in Note 8, which would limit the Plan's ability to transact at contract value with participants, was not probable. Further, the plan merger described in Note 8 did not impact the ability of the plan to transaction act at contract value, and there are no events that allowed the issuer to terminate the contract and that required the plan sponsor to settle an amount different than contract value paid.

Liquidation of the entire contract could cause a one-time adjustment to the aggregate contract value, resulting in a fair value different from the contract value. As a result of the merger described in Note 8, there was no one-time charge or other impact to the valuation of the contract as a result of the termination of the contract.

**Note 7 - Fair Value Measurements**

The following table presents information about the included plan assets measured at fair value on a recurring basis at July 15, 2022 and December 31, 2021. The Plan has excluded certain assets from the statement of net assets available for benefits at July 15, 2022 and December 31, 2021 (see Note 4).

- (2) This class represents investments in actively managed pooled separate accounts that invest in a variety of fixed-income investments, which may include corporate bonds, both U.S. and non-U.S. municipal securities, interest rate swaps, options, and futures.
- (3) This class represents investments in actively managed pooled separate accounts with investments in both equity and debt securities. The investments may include common stock, corporate bonds, U.S. and non-U.S. municipal securities, interest rate swaps, options, and futures.

There were no unfunded commitments or redemption restrictions on the investments described above.

**Note 8 - Plan Merger**

The Plan merged into the University Hospitals Health System, Inc. 403(b) Matched Retirement Savings Plan on July 15, 2022. Accordingly, all assets, participants, and their related account balances were transferred to the new plan.
