Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Geocent, L.L.C. 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 31, 2022 and December 31, 2021, and the related statements of changes in net assets available for benefits for the period from January 1, 2022 to March 31, 2022 and the year ended December 31, 2021, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Geocent, L.L.C. 401(k) Profit Sharing Plan and Trust financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of March 31, 2022 and December 31, 2021, and for the period from January 1, 2022 to March 31, 2022 and the year ended December 31, 2021, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the

information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of Geocent, L.L.C. 401(k) Profit Sharing Plan and Trust and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As disclosed in footnote 11, on October 15, 2021, the Plan Sponsor was acquired by Sev1Tech, LLC, a provider of IT modernization, cybersecurity, and cloud services to both federal and commercial customers. On November 24, 2021, the Board of Directors of Sev1Tech, LLC approved that the Geocent, L.L.C. 401(k) Profit Sharing Plan and Trust be merged into the Sev1Tech, LLC 401(k) Plan. The merger took place on March 31, 2022, on which date, all of the assets of the Plan were merged into the Sev1Tech, LLC 401(k) Plan. In connection with the merger, the Plan's assets custodian and recordkeeper also changed from John Hancock Life Insurance Company (U.S.A) to Fidelity Management Trust Company. The financial statements include all adjustment that have resulted from the merger. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Geocent, L.L.C. 401(k) Profit Sharing Plan and Trust's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a

whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1) Description of plan

The following description of the Geocent, L.L.C. 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

a) General

The Plan is a defined contribution plan covering substantially all employees of Geocent, L.L.C. who are age twenty-one or older. Eligible employees do not include those whose employment is governed by a collective bargaining agreement, non-resident aliens, and leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Participants are eligible to participate on the first day of the month following employment upon satisfying the age restriction of 21.

On October 15, 2021, Geocent, L.L.C. was acquired by Sev1Tech, LLC, a provider of IT modernization, cybersecurity, and cloud services to both federal and commercial customers. Prior to the Acquisition Date, Geocent, L.L.C. was the Plan sponsor. On November 24, 2021, the Board of Directors of Sev1Tech, LLC approved that the Geocent, L.L.C. 401(k) Profit Sharing Plan and Trust be merged into the Sev1Tech, LLC 401(k) Plan. Overall responsibility for administering the Plan rests with the Sev1Tech, LLC.

Refer to Note 11 for additional disclosures about the Plan merger.

b) Participants' elective contributions

Participants may elect to defer up to 90 percent of compensation on a pre-tax or Roth basis as elective deferrals to the Plan, not to exceed certain limits. In addition, a participant who has attained age 50 before the close of the Plan year shall be eligible to make catch-up contributions in accordance with the limitations under the Internal Revenue Code. For the period from January 1, 2022 to March 31, 2022, there were no employee contributions. For the year ended December 31, 2021, employee contributions were \$2,675,463.

c) Employer's matching contributions

The Employer may elect to make a discretionary non-safe harbor matching contribution to the Plan on the employees' behalf. For the year ended December 31, 2021, the Employer's contribution was equal to 50 percent of each employee's elective contribution, subject to a maximum of 8 percent of the employee's compensation allowed by the Plan, subject to the statutory limits.

d) True up contributions

The Employer may elect to make a discretionary true up contribution to the Plan on the employees' behalf. For the Plan period from January 1, 2022 to March 31, 2022 and year ended December 31, 2021, there were no true up contributions.

e) Participant accounts

Each participant's account is credited with the (1) participant's salary deferral, (2) Employer's matching contribution, (3) Employer's true-up contribution, and (4) an allocation of the Plan's earnings and administrative expenses. The allocation of earnings is based on the actual daily performance of the fund the participant chose to invest their money less any applicable fees. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

f) Vesting

Participants are one hundred percent vested in their salary deferrals accounts at all times. Participants become vested in Employer contributions according to the following schedule:

g) Payment of benefits

Upon termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's balance in his or her account. Participants may receive an in-service withdrawal of their vested account balance upon reaching 59 ½ years of age. Participants may also receive hardship distributions, as described in the Plan, from their deferral accounts. Balances under \$5,000 for terminated participants may be paid out at the discretion of the Company.

h) Plan expenses

The Company absorbs some of the administrative costs of the Plan. Administrative expenses paid by the Plan arise from fees for the processing of loans that are charged to their respected participants accounts. In addition, certain investment accounts charge asset and participation fees that are allocated among the respective participants.

i) Forfeitures

When termination of participation in the Plan occurs, the non-vested portion of the participant's account, as defined by the Plan, represents forfeitures. If the participant is re-employed and fulfills certain requirements, as defined in the Plan, the participant's account will be reinstated. Forfeitures can be used to pay administrative expenses incurred by the Plan, and then they must be used first to restore previous forfeitures of participants' accounts that met the criteria to be reinstated before they can be used to reduce Employer contributions. Forfeitures in the amount of \$-0- and \$70,186 for the period from January 1, 2022 to March 31, 2022 and year ended December 31, 2021, respectively, were used to reduce the Employer contributions into the Plan. There are \$69,308 and \$13,297 of forfeitures available to offset future administrative expenses and Employer contributions at March 31, 2022 and December 31, 2021, respectively.

j) Investment options

Participants direct employee contributions among fixed accounts and mutual funds (see schedule of assets held).

k) Note receivable - participant loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to 50 percent of their vested account balance or \$50,000 minus the highest outstanding balance of the participants total plan loans during the last 12 months. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant loan fund. Loan terms range from 1-5 years or longer for the purchase of a primary residence. The loans are secured by the balance in the participant's vested account and bear interest at 2% over the prime rate as posted in the Wall Street Journal when the loan is made. Principal and interest are paid ratably through payroll deductions. Interest rates range from 5.25% to 7.50% for the period from January 1, 2022 to March 31, 2022 and year ended December 31, 2021.

2) Summary of accounting policies

a) Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

b) Use of estimates

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America, requires the Plan administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

c) Investment valuation and income recognition

The Plan's investments are stated at fair market value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of pooled separate accounts are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year end.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net (depreciation) appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

d) Guaranteed investment contracts

Contributions under a group annuity contract can be allocated to guaranteed interest accounts, which are not, by definition an investment contract, but rather are an investment option offered under the John Hancock group annuity contract. The group annuity contract is a non-fully benefit-responsive investment contract. The guaranteed investment accounts guarantee the return of principle plus compound interest earned over a defined term, less any applicable contract or participant-level recordkeeping charges, provided all contributions remain in the account until the end of the guarantee period. Interest rates are established on the first day of each calendar month and apply to any regular ongoing contributions made to the guaranteed account in that month. For each reporting year in which a participant makes a contribution to a guaranteed account, a new account is established at the end of the contract year which applies for the remainder of the guaranteed term for that account. Inter-account transfers from guaranteed interest accounts may be subject to a market value adjustment, depending on the withdrawal amount and the reason for the withdrawal. A contract charge may be applied at contract termination, per the contract specifications. The investment in the contract is included in the financial statements at contract value which approximates fair value as reported to the Plan by John Hancock Life Insurance Company (USA).

e) Notes receivable – loans to participants

Participant loans are classified as notes receivable – loans to participants and are measured at the unpaid balance plus unpaid accrued interest. The Plan classifies all participant loans as in default when any scheduled payment remains unpaid as of the end of the last day of the calendar quarter following the calendar quarter in which the required payment was due. Defaulted loans are deemed distributed and recorded as benefits paid to participants in the statements of changes in net assets available for benefits. There were \$-0- and \$22,213 in deemed distributions recorded for the Plan period from January 1, 2022 to March 31, 2022 and year ended December 31, 2021, respectively.

f) Payment of benefits

Benefits are recorded when paid.

3) Investments

The Plan's investments are held by John Hancock Life Insurance Company (USA).

The Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) depreciated in value by \$(2,326,283) and appreciated in value by \$4,813,200 for the period from January 1, 2022 to March 31, 2022 and year ended December 31, 2021, respectively.

4) Federal income tax status

The Plan has adopted a prototype plan that was originally effective on April 1, 1995 but has since been amended on January 1, 2016. The prototype plan received a favorable determination letter from the Internal Revenue Service ("IRS") dated March 31, 2014, stating that the form of the Plan is acceptable under section 401(a) of the Internal Revenue Code ("IRC"). In accordance with Revenue Procedures 2006-6, the Company or Plan Sponsor has determined that it is eligible to and has chosen to rely on the current IRS prototype plan opinion letter. Once qualified, the Plan is required to operate in conformity with the code to maintain its qualification. The Plan itself has not separately applied for tax-exempt status; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt. Therefore, no provision for income taxes had been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions for a period of three years from filing these returns; however, there are currently no audits for any tax periods in progress.

5) Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, participants are 100% vested in their account balance. The plan merger described in Note 11 does not constitute a plan termination as defined under ERISA.

6) Related party transactions

The Plan invests in pooled separate accounts and in guaranteed investment contracts offered and managed by the custodian. Transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules. The payment of administrative expenses by the Plan constitutes related party fees.

7) Risks and uncertainties

The Plan provides for various instruments in pooled separate accounts and group contracts with the insurance company. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near future.

As a result of COVID-19, there has been heightened market risk and volatility associated with the pandemic, and this could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for

benefits, as mentioned above. Because of the uncertainty of the markets during this time, Plan management is unable to estimate the total impact the pandemic may continue to have.

8) Information prepared and certified by the custodian - unaudited

9) Fair value measurement

Pooled separate accounts: Valued at net asset value (NAV), which approximates fair value, are marked-to-market on a daily basis.
