Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the CCG 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of January 27, 2022 and December 31, 2021, the related statements of changes in net assets available for benefits for the period and year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of January 27, 2022 and December 31, 2021, for the period from January 1, 2022 through January 27, 2022, and for the year ended December 31, 2021, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management has determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Notes to the Financial Statements

January 27, 2022 and December 31, 2021

(1) Description of plan

The following description of the CCG 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan was a defined contribution plan which was adopted on January 1, 2004 to provide retirement benefits for employees of Cumberland Consulting Group, LLC (the "Plan Sponsor" or "Company"). The Plan covered substantially all full-time salaried employees, and certain hourly employees in the Company's Managed Service practice, that had completed three months of service ("participants"). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective January 27, 2022, the Plan was merged into the 401(k) Savings Plan established by Providence Health & Services ("Providence 401(k) Plan"). Participants were eligible to make contributions into the Providence 401(k) Plan beginning January 1, 2022. All participant account balances and Plan assets were transferred on January 27, 2022 in accordance with the Plan merger document.

(b) Contributions

Prior to January 1, 2022, participants could voluntarily make qualified retirement contributions to the Plan which were deductible by the participants for federal income tax purposes under Section 401(k) of the Internal Revenue Code ("IRC") or could be made after-tax in the form of a Roth contribution. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. In order to participate, employees were required to make a deferral election of whole percentage points of eligible compensation with a minimum of 1% up to a maximum of 85%. Unless an employee elected otherwise, he or she was automatically enrolled to contribute 3% of eligible compensation upon meeting the eligibility requirements.

The Plan Sponsor made safe harbor matching contributions equal to 100% of each participant's contributions up to 3% of compensation, and 50% of each participant's contributions exceeding 3% up to 5% of compensation. Plan Sponsor and participant contributions could not exceed the maximum amount deductible for federal income tax purposes.

The Plan also provided that the Plan Sponsor could contribute each year qualified non-elective discretionary contributions and non-elective discretionary contributions (together "discretionary contributions") authorized by the Plan Sponsor's Board of Directors; however, annual discretionary contributions by the Plan Sponsor were not required. There were no discretionary contributions for the period January 1, 2022 through January 27, 2022 or the year ended December 31, 2021.

(c) Participant accounts

Each participant's account was credited (charged) with the participant's and Plan Sponsor contributions, allocations of investment earnings (losses), and administrative expenses. Allocations were based on participant compensation or account balances as defined in the plan agreement. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

(d) Vesting

Participants were immediately vested in their elective salary deferral and Plan Sponsor safe harbor contributions plus actual earnings (losses) thereon. Vesting in the Plan Sponsor's discretionary contributions was based on years of continuous service. Participants became fully vested after three years of continuous service and, became fully vested as of the plan merger on January 27, 2022.

(e) Notes receivable from participants

Each participant could borrow from his or her fund accounts a minimum of \$1,000 up to 50% of his or her vested account balance. The notes were secured by the balances in the respective participants' accounts and bore interest at fixed rates ranging from 4.25% to 8.00% at the time of origination. Principal and interest were paid ratably through payroll deductions.

(f) Payment of benefits

On termination of service due to death, permanent disability, or retirement, a participant could elect to receive either a lump-sum payment or annual installments over a specified period equal to his or her entire account. For termination of service due to other reasons, a participant was entitled to receive only the vested interest in his or her account as a lump-sum distribution.

(g) Forfeited accounts

Forfeitures are created when participants terminate employment prior to becoming fully vested in the Plan Sponsor contribution portion of their accounts. Such forfeitures were used to pay reasonable plan expenses, reduce Plan Sponsor contributions or reallocate as Plan Sponsor contributions. There were no forfeited nonvested accounts as of January 27, 2022. Forfeited nonvest accounts as of December 31, 2021 totaled \$1,267.

(h) Hardship withdrawals

The Plan permitted distributions in the event of a hardship, as defined in the plan agreement. These distributions were taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant was younger than age 59½. Hardship withdrawals were limited to the participant's elective account balance.

(i) Administrative expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that were paid by the Plan Sponsor were excluded from these financial statements. Fees related to the administration of notes receivable from participants and processing of distributions were charged directly to applicable participants' accounts. Certain fees incurred by the Plan for investment management services were netted within the net appreciation (depreciation) in the fair value of the investments.

(2) Summary of significant accounting policies

(a) Basis of accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

(b) Investment valuation and income recognition

Investments are reported at fair value or contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. These investment values are discussed more fully in Notes 4 and 5.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the period/year.

(c) Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of January 27, 2022 December 31, 2021.

(d) Payment of benefits

Benefits are recorded when paid.

(e) Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(f) Events occurring after the reporting date

The Plan Sponsor has evaluated events and transactions that occurred between January 27, 2022 and January 9, 2023, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Certified information

Certain information related to investments and notes receivable from participants presented and disclosed in the accompanying financial statements, including investments at fair and contract value as of December 31, 2021, notes receivable from participants held at December 31, 2021, net appreciation (depreciation) in fair value of investments, interest and dividends, and income for the period ended January 27, 2022 and the year ended December 31, 2021, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Great-West Life & Annuity Insurance Company and Great-West Trust Company, LLC (collectively, "Great-West").

(4) Fair value measurements

The Plan's investment in pooled separate accounts are measured at net asset value ("NAV") as a practical expedient to estimate fair value and, therefore, have not been classified in the fair value hierarchy. The NAV is based on the market value of the underlying investments held by the pooled separate accounts at year end. The NAV as a practical expedient would not be used if it is determined to be probable that an account will sell the underlying investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

The following table summarizes investments for which fair value is measured using the NAV as a practical expedient as of January 27, 2022 and December 31, 2021, respectively.

(5) Investment contract with insurance company

The Plan held a benefit-responsive investment contract with an insurance company, Great-West Life & Annuity Insurance Company. The contract value of the investment contract was \$1,070,905 at December 31, 2021. The insurance company maintained the Plan's contributions in a general account which was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The crediting rate was based on a formula established by the contract issuer. The crediting rate was reviewed on a quarterly basis for resetting. The guaranteed investment contract did not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Great-West Life & Annuity Insurance Company represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations could have been affected by future economic and regulatory developments.

Certain events limited the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events were probable of occurring that might have limited the ability of the Plan to transact at contract value with the contract issuers and that also would have limited the ability of the Plan to transact at contract value with the participants.

(6) Income tax status

The Plan Sponsor adopted a volume submitter profit sharing plan, which received a favorable opinion letter from the Internal Revenue Service ("IRS") on March 31, 2014, which stated that the volume submitter plan was designed in accordance with the applicable sections of the IRC. The Plan itself had not received a opinion letter from the IRS stating that the Plan is qualified under Section 401(a) of the IRC. However, the plan administrator believes that the adopted volume submitter plan, as amended, was designed, and was being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator analyzed the tax positions taken by the Plan, and has concluded that as of January 27, 2022 and December 31, 2021, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there were no audits for any tax periods in progress.

(7) Related party and party-in-interest transactions

The Plan's investments were managed by Great-West Life & Annuity Insurance Company and, therefore, related transactions qualified as party-in-interest transactions under ERISA. As described in Note 1, the Plan paid expenses to various service providers which also qualified as party-in-interest transactions. The Plan also held notes receivable from participants which qualified as party-in-interest transactions.
