INDEPENDENT AUDITORS' REPORT

**To the Trustees of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of American Office 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of October 21, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period January 1, 2022 through October 21, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of American Office 401(k) Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of October 21, 2022 and December 31, 2021, and for the period January 1, 2021 through October 21, 2022, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of American Office 401(k) Retirement Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination

As disclosed in Note A and Note F to the financial statements, the Plan ceased effective October 21, 2022. All balances were distributed to the participants, rolled over to a qualified plan, or used to pay Plan expenses as of October 31, 2022. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about American Office 401(k) Retirement Savings Plan's ability to continue as a going concern for one year from the date of the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

NOTES TO FINANCIAL STATEMENTS
October 21, 2022 and December 31, 2021

NOTE A – DESCRIPTION OF THE PLAN

The following description of the American Office 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan is a defined contribution retirement Plan established effective February 1, 1996, which provides a system of pre-tax savings for the benefit of employees of American Office Equipment Co., Inc. (the Sponsor). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan administrator is responsible for the oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance. The Plan adopted the provisions of the CARES Act and SECURE Act during 2020. The Plan document was formally amended June 15, 2022 in accordance with the legislation.

As disclosed in Note F to the financial statements, the Plan ceased effective October 21, 2022 and all assets, liabilities, participants, and obligations were distributed or otherwise removed from the Plan. Participants were notified of the change in June 2022 and contributions to the Plan ceased to be made to the custodians as of June 10, 2022.

2. Eligibility

Each employee is eligible to make contributions to the Plan on the first day of each Plan quarter following the first year of employment.

3. Contributions

Deferral Elections

Each year, participants may contribute up to the maximum allowed by the applicable laws. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant.

Employer Discretionary Contributions

A discretionary contribution may be made by the Sponsor as determined by the Sponsor's board of directors. There were no discretionary contributions for the period January 1, 2022 through October 21, 2022.

Employer Matching Contributions

Each employee is eligible to receive matching contributions after completing one year of service provided they are employed on the last day of the Plan year, or become disabled or retire during the Plan year. The Sponsor makes a matching contribution equal to 20% of the participant's contribution up to the first 5% of the participant's compensation.

NOTE A – DESCRIPTION OF THE PLAN – Continued

4. Participant Accounts

Each participants' account is credited with the participant's contributions and allocation of (a) the Sponsor's contributions and (b) Plan earnings, and are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

5. Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Sponsor's contributions portion of their accounts is based on years of service. Participants are 20% vested after two years of service and vesting increases 20% for each year thereafter. A participant is fully vested after six years of service. All participants became fully vested upon termination of the Plan.

6. Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 and up to 50% of their vested account balance, not to exceed a maximum of \$50,000. The number of loans outstanding per participant may not exceed one at any time. Interest rates during the period January 1, 2022 through October 21, 2022 range from 5.25%-7.50%, which is commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid through payroll deductions.

7. Payment of Benefits

Upon termination of service due to death, disability, retirement or termination of service due to other reasons, a participant or the participant's estate or beneficiary will receive a lump-sum amount equal to the value of the participant's vested interest in the participant's account. Hardship withdrawals are permitted by the Plan. The Plan adopted the provision of the CARES Act and SECURE Act which allowed qualified individuals to receive payments of benefits up to \$100,000 without the 10% penalty from January 1, 2020 to December 31, 2020. Individuals who received qualified distributions under the CARES Act can elect to pay the distribution back within three years. As of October 21, 2022, no participants elected to pay back their qualified distribution.

8. Forfeited Accounts

At October 21, 2022 and December 31, 2021, there was \$-0- and \$1,121 in forfeited non-vested accounts. This account may be used to reduce future Sponsor contributions or pay Plan expenses. During the period January 1, 2022 through October 21, 2022, \$4,184 was used to pay Plan expenses.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – Continued

2. Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

3. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrators determine the Plan's valuation policies utilizing information provided by investment advisors, and the custodian. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. Notes Receivable from Participants

Notes receivable from participants are measured at unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of October 21, 2022 and December 31, 2021.

5. Payment of Benefits

Benefits are recorded when paid.

6. Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. There were no excess contributions payable at October 21, 2022.

7. Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net depreciation in fair value of investments.

8. Subsequent Events

The Plan has evaluated events through January 5, 2023, the date the financial statements were available to be issued.

NOTE C – INFORMATION CERTIFIED BY CUSTODIAN

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at October 21, 2022 and December 31, 2021 and net depreciation in fair value of investments, interest and dividends for the period January 1, 2022 through October 21, 2022, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Matrix Trust Company, LLC, the custodian of the Plan.

NOTE D – FAIR VALUE OF FINANCIAL INSTRUMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets:
- Quoted prices for identical or similar assets or liabilities in inactive markets:
- Inputs other than quoted prices that are observable for the asset or liability:
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 21, 2022 and December 31, 2021.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust: Valued at the net asset value, which is based on the values of the underlying investments as determined by quoted market prices, less any liabilities.

NOTE E – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

NWPS is the record keeper for the Plan, and Janney Montgomery Scott, LLC (Janney) is the advisor for the Plan, therefore transactions with the Plan and NWPS or Janney qualify as party-in-interest transactions. During the year ended October 21, 2022, the Plan paid \$47,592 to NWPS and \$17,794 to Janney for plan administration and advisory expenses, respectively.

NOTE F – PLAN TERMINATION

The Plan Sponsor executed an asset sale on May 31, 2022. At that time, the Plan was frozen, all participants were notified of the pending Plan termination and they became 100% vested. Participants were given the option to rollover their account into a qualified IRA plan or take a full distribution of their account. All balances were distributed to the participants, rolled over to a qualified plan, or used to pay Plan expenses as of October 21, 2022.

NOTE G – TAX STATUS

The IRS issued a non-standardized prototype profit sharing opinion letter to CCH Incorporated dba FTWilliam Com dated June 30, 2020, stating that its prototype plan document was designed in accordance with applicable Internal Revenue Code (IRC) requirements as of that date. Although the Sponsor has not applied for a determination letter for the Plan and although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
