We have performed audits of the accompanying financial statements of the Educational Playcare, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 7, 2022 (date of merger) and December 31, 2021, and the related statements of changes in net assets for the period from January 1, 2022 to March 7, 2022 (date of merger) and for the year ended December 31, 2021, and the related notes to the financial statements.

(1) Description of plan

The following description of the Educational Playcare, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan was a defined contribution plan which was adopted to provide retirement benefits for employees of Educational Playcare, Inc. (the "Employer"). The Plan covered substantially all employees who were age twenty-one or older and had completed one year of service ("participants"). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective January 1, 2022, the Plan was terminated. On March 7, 2022, all of the net assets of the Plan were merged into the BrightPath 401(k) Plan as the result of the Employer being acquired. Plan management believes that the merger was a tax-exempt transaction under the applicable provisions of the Internal Revenue Code ("IRC") and therefore, is not subject to federal income taxes.

(b) Contributions

Prior to January 1, 2022, participants could voluntarily make qualified retirement contributions to the Plan which could be after-tax Roth deferrals or pre-tax deferrals deductible by the participants for federal income tax purposes under Section 401(k) of the Internal Revenue Code ("IRC"). Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants directed the investment of their contributions into various investment options offered by the Plan. Participant contributions were permitted up to 90% of compensation subject to certain IRC limitations.

The Employer provided a safe harbor matching contribution of 100% of a participant's contributions up to 3% of the participant's compensation contributed to the Plan and 50% of a participant's contributions between 3% and 5% of the participant's compensation contributed to the Plan. Employer contributions could not exceed the maximum amount deductible for federal income tax purposes.

The Plan also provided that the Employer could contribute a discretionary profit sharing contribution each year in an amount authorized by the Employer; however, the Employer made no profit sharing contribution in 2022 or 2021.

(c) Participant accounts

Each participant's account was credited with Employer contributions as calculated above and participant contributions. Each participant's account was credited or charged the investment earnings (losses) of the investment options selected by the participant and an allocation of administrative expenses. Allocations of administrative expenses were based on account balances as defined in the plan agreement. The benefit to which a participant was entitled is the benefit that could be provided from the participant's vested account.

(d) Vesting

Participants were immediately vested in their elective salary deferral, Employer safe harbor matching contributions, plus actual earnings (losses) thereon. Vesting in the Employer's discretionary profit sharing contributions and earnings thereon vested as follows:

Participants could also become 100% vested upon full or partial termination of the Plan, or upon death or disability while employed. Participants became 100% vested in all accounts upon the merger of the Plan as described in Note 1(a).

(e) Notes receivable from participants

Participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes receivables from participants were secured by the balance and bore interest at fixed rates ranging from 4.25% to 6.50% as of December 31, 2021, which was commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest were collected ratably through payroll deductions.

(f) Payment of benefits

On termination of service due to death, permanent disability, or retirement, a participant could elect to receive a lump-sum payment equal to his or her entire account. For termination of service due to other reasons, a participant was entitled to receive only the vested interest in his or her account as a lump-sum distribution.

(g) Forfeited accounts

Forfeitures were created when participants terminated employment prior to becoming fully vested in the Employer discretionary profit sharing contributions portion of their accounts. Such forfeitures reduced the Employer's contributions to the Plan or to pay plan expenses. There were no forfeited nonvested accounts as of March 7, 2022. On December 31, 2021, forfeited nonvested accounts totaled \$5,680. No forfeitures were used to reduce employer contributions or pay plan expenses in 2022. Forfeitures of \$2,750 were used in 2021.

(h) Hardship withdrawals

The Plan permitted distributions in the event of a hardship, as defined in the plan agreement. These distributions were taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant was younger than age 59½. Hardship withdrawals were limited to the participant's elective account balance.

(i) Administrative expenses

Certain administrative expenses were paid by the Employer; while certain administrative expenses were paid by the Plan. Fees related to the processing and administration of notes receivable from participants and the processing of distributions were charged directly to the participant's account. Certain fees incurred for investment management services were also paid by the Plan and included in net appreciation in fair value of investments.

(2) Summary of significant accounting policies

(a) Basis of accounting

The financial statements of the Plan were prepared under the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America ("U.S. GAAP").

(b) Investment valuation and income recognition

Investments were stated at fair value, except for the fully benefit-responsive investment contract, which was reported at contract value (see Note 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determined the Plan's valuation policies utilizing information provided by the investment advisers and The Lincoln National Life Insurance Company ("Lincoln"). See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Dividend income was recorded on the ex-dividend date. Interest income was recorded on the accrual basis. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold as well as held during the year or period.

(c) Notes receivable from participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants were reclassified as distributions based upon the terms of the plan document.

(d) Payment of benefits

Benefits were recorded when paid.

(e) Use of estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(f) Events occurring after reporting date

The Employer has evaluated events and transactions that occurred between March 7, 2022 and January 11, 2023, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Certified information

Certain information related to investments and notes receivable from participants reported and disclosed in the accompanying financial statements, including the fair and contract value of investments and notes receivable from participants held at March 7, 2022 and December 31, 2021, and net appreciation (depreciation) in fair value of investments, dividend income, and interest on notes receivable from participants for the period from January 1, 2022 through March 7, 2022 and for the year ended December 31, 2021 was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Lincoln.

(4) Investments measured at net asset value using the practical expedient

The Plan's pooled separate accounts were measured at net asset value ("NAV") per share as a practical expedient to estimate fair value and, therefore, have not been classified in the fair value hierarchy.

(5) Investment contract with insurance company

The Plan entered into a guaranteed investment contract with Lincoln. Lincoln maintained the Plan's contributions in a general account which was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. There were no reserves against contract value for credit risk of the contract issuer or otherwise. As of December 31, 2021, the contract value of the investment in the Lincoln guaranteed investment contract was \$5,680.

Certain events limited the ability of the Plan to transact at contract value with the issuer. Such events included the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Employer or other Employer events (for example, divestitures or spin-offs of a subsidiary) that could cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any such event, which would have limited the Plan's ability to transact at contract value with participants, occurred.

The investment contract did not permit Lincoln to terminate the agreement prior to the scheduled maturity date.

(6) Income tax status

The Employer adopted a volume submitter profit sharing plan that received a favorable opinion determination letter on March 31, 2014, in which the Internal Revenue Service ("IRS") stated that the volume submitter profit sharing plan was designed in accordance with the applicable sections of the IRC. The Plan was required to operate in conformity with the IRC to maintain its qualification. The Plan itself had not received an opinion determination letter from the IRS stating that the Plan was qualified under Section 401(a) of the IRC. The Plan had been amended since receiving the opinion letter. However, the plan administrator believes that the adopted volume submitter profit sharing plan was designed and was being operated in compliance with the applicable requirements of the IRC and was therefore, qualified and exempt from taxation.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator had analyzed the tax positions taken by the Plan, and had concluded that as of March 7, 2022 and December 31, 2021, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(7) Untimely remittance of participant contributions

The Employer was required by Department of Labor's regulation to remit participant contributions and repayments of notes receivable from participants as soon as practicable, but by no later than the fifteenth business day following the end of the month in which the amounts were withheld from wages. For certain contributions withheld in 2021 and 2020, the funds were not remitted timely. Imputed lost earnings applicable to the contributions have not been calculated and contributed to the Plan.

(8) Related party and party-in-interest transactions

Plan investments are units of pooled separate accounts and a guaranteed investment contract managed by Lincoln, therefore, these transactions qualify as party-in-interest transactions under ERISA. As described in Note 1, the Plan paid expenses to various service providers which also qualify as party-in-interest transactions. The Plan also holds notes receivable from participants which qualify as party-in-interest transactions.

(9) Risks and uncertainties

The Plan utilized various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility.
