We have performed audits of the financial statements of Nebraska Orthopaedic and Sports Medicine P.C. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 15, 2022 and December 31, 2021, and the related statements of changes in net assets available for benefits for the period from January 1, 2022 to March 15, 2022 and the year ended December 31, 2021, and the related notes to the financial statements (the financial statements).

As discussed in Note 1, “General” section to the financial statements, the management of Nebraska Orthopaedic and Sports Medicine P.C. 401(k) Profit Sharing Plan, the Plan Sponsor, approved a resolution effective March 15, 2022 to merge the Plan into the Nebraska Orthopaedic Center, P.C. 401(k) Profit Sharing Plan. Our opinion has not been modified with respect to this matter.

1. Plan Description

The following brief description of the Nebraska Orthopaedic and Sports Medicine P.C. 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

Effective March 15, 2022, the Plan was merged into the Nebraska Orthopaedic Center, P.C. 401(k) Profit Sharing Plan. Net Plan assets totaling \$27,880,697 were transferred to the Nebraska Orthopaedic Center, P.C. 401(k) Profit Sharing Plan on March 15, 2022.

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees of Nebraska Orthopaedic and Sports Medicine P. C. (the Company).

Effective January 1, 2022, participants began making contributions to the Nebraska Orthopaedic Center, P.C. 401(k) Profit Sharing Plan and no longer contributed to this plan. Prior to January 1, 2022, employees were eligible to make pre-tax and after-tax (Roth and voluntary) salary reduction contributions after attaining age 21 and completing one year of service in which they worked at least 1,000 hours. Eligible employees are automatically enrolled in the Plan, with salary deferral contributions starting at 4% of their eligible compensation. On January 1 of each year, the employee's deferral rate will be increased by one percentage point until it reaches a total of 10% of their eligible salary. Employees have the option to choose their own salary deferral percentages in the Plan before their respective automatic enrollment period begins and at any subsequent time during the Plan year. Eligible employees may become participants on the first day of the quarter following the date on which entry requirements were fulfilled.

Participants are eligible for discretionary profit sharing and qualified nonelective contributions if they were active participants during the Plan year.

Contributions

Through December 31, 2021, participants could contribute up to 100% of pre-tax and after-tax annual compensation in connection with the 401(k) provisions of the Plan up to the maximum allowable by law. At any time, a participant may elect not to contribute. Participants may also contribute amounts representing distributions from other qualified plans. The Plan is a "Safe harbor 401(k) plan", whereby the Company will make qualified nonelective contributions equal to 3% of eligible compensation during the time period the participant is actively contributing. The Company also may make discretionary profit sharing contributions. All participants who are eligible to make deferral contributions and who are projected to attain age 50 before the close of the calendar year shall be eligible to make catch-up contributions. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of a) the Company's discretionary profit sharing and qualified nonelective contributions and b) Plan earnings or losses. The Company's discretionary profit sharing and qualified nonelective contributions are allocated among participants based upon eligible compensation of participants. Plan earnings or losses are allocated on the basis of actual results of the investments selected by each participant. Certain investments are maintained in individual member accounts managed by Principal Trust Company (Principal). Certain investments are maintained in individual member accounts in participant directed brokerage accounts as selected by the applicable participant.

Vesting

Participants are vested immediately in their contributions and the Company's contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance from pre-tax and after-tax Roth salary reduction contributions or rollover contributions. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates. Principal and interest payments must be made in at least quarterly installments.

Payment of Benefits

Upon termination, retirement, disability, or death the participant or beneficiary may elect to receive either a lump sum or installment/annuity payments equal to the value of the vested funds allocated to the participant's account. The Plan requires that distribution payments between \$1,000 and \$5,000 be directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect otherwise. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option. Benefits are recorded when paid.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

Presentation of Participant-Directed Funds

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting-Defined Contribution Pension Plans*.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Other

Certain investment management and recordkeeping expenses are paid by the Plan and are included in administrative expenses. Other certain expenses specifically incurred by or attributable to individual participants are paid from the applicable participants' accounts. Investment related expenses are included in net appreciation in fair value of investments. Audit fees are paid by the Company and are excluded from these financial statements.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through January 10, 2023, noting no items requiring disclosure.

3. Information Certified by Principal

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Principal, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplemental information.

5. Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used as of December 31, 2021. There were no Plan investments as of March 15, 2022.

Collective Investment Trusts: The estimated value of the collective investment trusts is at the net asset value (NAV). The use of NAV as fair value is deemed appropriate as the collective investment trust funds do not have finite lives, unfunded commitments relating to these types of investments, or significant restrictions on redemptions. Since the participants have the ability to redeem the accounts at NAV, as of the measurement dates on a daily basis, the accounts are properly categorized as a Level 1 fair value measurement.

Pooled Separate Accounts: Valued at the NAV of its underlying investments. The accounts include investments in fixed securities, mutual funds, common stocks which have observable level 1 or level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets. FASB ASC 820, *Fair Value Measurement*, allows NAV per share to estimate the fair value as long as certain requirements are met. It is the Plan's assessment that these accounts meet those requirements. Since the participants have the ability to redeem the accounts at NAV, as of the measurement dates on a daily basis, the accounts are properly categorized as a Level 1 fair value measurement. The accounts also have no unfunded commitments.

Mutual Funds: Valued at the daily closing price as reported by the funds. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their NAV and to transact at that price. Funds held by the Plan are deemed to be actively traded.

Participant-Directed Brokerage Accounts: Valued at the NAV of its underlying investments. These accounts hold various investment in cash and equivalents (Level 1) and equity securities – common stocks and mutual funds (Level 1) that have publicly quoted pricing inputs. The accounts also hold certain fixed bond investments and other investment vehicles - hedge and private equity funds (Level 2) whereby the value is at NAV with certain observable inputs.

6. Tax Status

The Plan is qualified as a profit sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code of 1986, as amended.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2018.

7. Related Party Transactions

Certain Plan investments are pooled separate accounts and collective investment trusts managed by Principal. Principal is a custodian of the Plan through March 15, 2022, and therefore, these transactions qualify as party-in-interest transactions.
