Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Dyehard Fan Supply 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of March 31, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period January 1, 2022 to March 31, 2022, and the related notes to the financial statements.

NOTE 1 – PLAN DESCRIPTION

The following description of the Dyehard Fan Supply 401(k) Profit Sharing Plan (the “Plan”) provides only general information concerning the operation of the Plan. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering employees of Dyehard Fan Supply, LLC (the “Company”) who have one month of service and are age 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Merger

The Plan sponsor, Dyehard Fan Supply, LLC, approved the merger of the Plan into the Teall Capital Partners, LLC 401(k) Profit Sharing Plan effective January 1, 2022. As a result, all assets were transferred from the Plan into the Teall Capital Partners, LLC 401(k) Profit Sharing Plan on March 31, 2022 (asset transfer date).

Contributions

Participants may elect to defer a percentage of their annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and pooled separate accounts as investment options for participants. The Company is required to make a matching contribution of 100% of elective deferral contributions that are not over 4% of eligible compensation. The Company may make additional discretionary contributions to the Plan. No discretionary contributions were made during the period January 1, 2022 to March 31, 2022. Contributions are subject to certain statutory limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching contribution and, (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and the Company’s required matching contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at 6.75% which is commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting. Investments held by a defined contribution plan are required to be reported at fair value.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees related to the administration of the Plan, notes receivable from participants and benefit payments are charged directly to the participant accounts and are included in administrative expenses.

Date of Management's Review of Subsequent Events

Subsequent events were evaluated through January 12, 2023, which is the date the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs would only be used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

The underlying securities in pooled separate accounts are listed on national securities exchanges and/or have a readily determinable fair value. These investments are valued on the basis of year-end closing prices. The Plan has concluded that the net asset value as reported by the insurance company approximates fair value of the investments. The NAV is calculated in a manner consistent with GAAP for investment companies. Because these investments are valued similarly to mutual funds, the Plan believes the pooled separate accounts should be a level 1 asset to allow for consistent disclosure.

NOTE 4 – INFORMATION PREPARED AND CERTIFIED BY PRINCIPAL TRUST COMPANY

The March 31, 2022, and December 31, 2021, Statements of Net Assets Available for Benefits, the investment activities included on the Statement of Changes in Net Assets Available for Benefits for the period January 1, 2022 to March 31, 2022, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by Principal Trust Company in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes total investments of \$0 and \$1,301,622 at March 31, 2022 and December 31, 2021, respectively, and related investment loss of \$190,189 for the period January 1, 2022 to March 31, 2022. The information certified also includes notes receivable from participants of \$0 and \$25,632 at March 31, 2022 and December 31, 2021, respectively.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Principal Life Insurance Company, who acts as the record keeper for the Plan. The record keeper is a related entity to the Custodian. Fees paid to Principal Life Insurance Company qualify as party-in-interest transactions and amounted to \$3,217 for the period January 1, 2022 to March 31, 2022. The Company provides the Plan with certain accounting and administrative services for which no fees are charged. All such transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all contributions to the Plan would cease and all affected participants would become 100% vested in their accounts.

NOTE 7 – INCOME TAX STATUS

The Plan adopted a non-standardized pre-approved plan sponsored by Nova 401(k) Associates, Inc. The non-standardized pre-approved plan has received a favorable advisory letter from the Internal Revenue Service dated June 30, 2020 as to the plan's qualified status. The advisory letter has been relied upon by the Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan has determined that it does not have any material unrecognized tax benefits or obligations as of March 31, 2022. The Plan is generally subject to routine audits by the Internal Revenue Service and/or Department of Labor for three years, including 2019, 2020 and 2021. There are currently no audits for any periods in progress.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
