Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Bergmann Associates Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits – modified cash basis as of March 1, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits – modified cash basis for the period from January 1, 2022 to March 1, 2022, and the related notes to the financial statements.

MARCH 1, 2022 AND DECEMBER 31, 2021

NOTE A: DESCRIPTION OF THE PLAN

The following description of the Bergmann Associates Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Bergmann Associates, Architects, Engineers, Landscape Architects, & Surveyors, D.P.C. (the “Company”). New employees are eligible to participate in the Plan at the beginning of the next month following the date of hire. Independent contractors, co-op employees, and contract workers hired through, or employees of, an outside agency are not eligible to participate in the Plan. Effective January 1, 2009, staff consultants, temporary construction inspectors and temporary employees are eligible to enter the Plan upon completing 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Eligible participants are entitled to defer up to the maximum amount or percentage allowed of their annual compensation, as defined in the Plan, as a qualified pre-tax contribution subject to maximum annual dollar contribution restrictions of ERISA and the Internal Revenue Service. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company will make a matching contribution of 50% of the participant’s contribution, up to an annual match of \$2,500. The Company also has the option of making annual discretionary contributions to the Plan. Employees becoming eligible to join the Plan will be automatically enrolled in the Plan and will contribute 3% of compensation, unless the employee elects not to join the Plan or to contribute a different amount. Effective September 1, 2016, the Plan was amended to include an automatic 1% percent increase in each Participant’s Deferral Percentage, up to a maximum of 85%, each year on May 1. This automatic increase excludes highly compensated employees and those Participants who elect to opt out of the Plan. Effective May 1, 2020, the Plan was amended to reduce the Participant Deferral Percentage from a maximum of 85% of compensation to a maximum of 70%. Effective January 1, 2022, the Plan was amended to cease all contributions into the Plan. See Note F.

Participants direct the investment of contributions into various investment options offered by the Plan.

Participant accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s match, (b) the Company’s discretionary contribution, and (c) plan earnings. Allocations of the Company’s discretionary contributions are based on participants’ compensation for the year in relation to total compensation of all participants for the year. Allocations of plan earnings are based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participant notes receivable

Participant notes receivable are measured and valued at their unpaid principal balance plus any accrued but unpaid interest. Participants are permitted to borrow up to 50% of the vested balance in their plan accounts to a maximum of \$50,000. The notes are payable over terms up to five years (longer if for the purchase of a principal residence) and bear interest at a fixed rate. The fixed interest rate is derived from the prime rate of interest plus 1% at origination. Principal and interest payments on the notes are redeposited into the participants' accounts based on their current investment allocation elections.

Effective April 1, 2017, the Plan allows for the rollover of participant notes receivable from another retirement plan into the Plan.

As of March 1, 2022, all participant notes receivable were repaid, distributed or rolled into the new plan noted in Note F.

Payment of benefits

Upon termination of service, benefits may be paid in a lump-sum amount or periodic payments, not to exceed the beneficiary's life expectancy.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants become vested in Company contributions plus actual earnings thereon based on years of continuous service. A participant receives credit for a year of service if they complete at least 1,000 hours of service during the plan year.

Employees terminating after October 1, 2013 are vested according to the following schedule:

1	25%
2	50%
3	75%
4	100%

Employees who terminated prior to October 1, 2013, were subject to a six-year vesting schedule and will remain under this schedule unless subsequently rehired.

Forfeited amounts

Any forfeitures arising under the Plan are applied against the Company's matching contribution. There were no forfeitures utilized for the period from January 1, 2022 to March 1, 2022. As of March 1, 2022, the remaining forfeiture balance was rolled into the new plan noted in Note F.

NOTE B: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The Plan's policy is to prepare its financial statements on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Generally, contributions and investment earnings are recorded as received and benefits and administrative fees are recorded as paid.

Investment valuation and income recognition

Investments in mutual funds are carried at fair value, which is determined based on the quoted market prices of the underlying securities. Investments in guaranteed income accounts are valued at contract value, which approximates fair value, as upon discontinuance of the contract an adjustment does not apply.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the modified cash basis. Dividends are recorded on the ex-dividend date.

The Plan presents in the statement of changes in net assets available for benefits – modified cash basis, the net appreciation or depreciation in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments.

Valuation of guaranteed income funds

The Plan holds an investment in a Guaranteed Income Fund which qualifies as a traditional fully benefit-responsive contract and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Contributions made to the guaranteed investment contracts are invested in the Prudential Retirement Insurance and Annuity Company's Guaranteed Income Fund. The principal invested in the Fund is guaranteed as long as the contract is in force. The Guaranteed Income Fund has interest rates established semi-annually, for the entire fund, regardless of when the funds are deposited. The credited interest rate may stay the same or change semi-annually.

The Guaranteed Income Fund is a general account product. The methodology for calculating the interest crediting rate is based on consideration of current economic and market conditions, the general interest rate environment and both the expected and actual experience of a reference portfolio within the issuer's general account. The interest crediting rates are established without a specific formula. Interest crediting rate is reset semi-annually and the minimum crediting rate under the contract is 1.50%. The gross guaranteed interest rate at March 1, 2022 and December 31, 2021 was 1.50%.

The average yield earned by the plan for the guaranteed income fund can be derived by dividing the earnings on the last day of the plan year by the end of plan year fair value and then annualizing the result. The average for the period from January 1, 2022 to March 1, 2022 and the year ended December 31, 2021 is 1.50%

Generally, there are not any events that could limit the ability of the Plan sponsor and/or plan participants to transact at contract value with Prudential Retirement Insurance & Annuity Company. There are not any events that allow the issuer to terminate the contract and which require the Plan sponsor to settle at an amount different than contract value, paid either within 90 days or over time.

The investment in guaranteed investment contracts is an alternative investment. Because alternative investments are not readily marketable, their estimated value is subject to uncertainty and therefore may differ from the value that would have been used had a ready market for such investments existed. Such difference could be material.

Administrative expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits. Participant loan fees are allocated to the respective participant's account.

Revenue sharing agreements

The Plan has entered into revenue credit agreements with its investment providers whereby the Plan receives credits paid into an ERISA account. Qualified plan expenses may be paid from the ERISA account. During the Plan period from January 1, 2022 to March 1, 2022, the Plan received approximately \$14,000 which reduced Plan expenses on the accompanying statement of changes in net assets available for benefits – modified cash basis. As of March 1, 2022, the remaining account balance was rolled into the new plan noted in Note F.

Payment of benefits

Benefits are recorded when paid.

Use of estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates and assumptions.

Subsequent events

The Plan has conducted an evaluation of potential subsequent events occurring after the statement of net assets available for benefits date through January 16, 2023, which is the date the financial statements are available to be issued. See Note F.

NOTE D: FAIR VALUE MEASUREMENTS

Accounting principles establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 Measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE D: FAIR VALUE MEASUREMENTS, Cont'd

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 1, 2022 and December 31, 2021.

Mutual Funds: Valued at the net asset value ("NAV") of shares held by the Plan at year end. (Level 1)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E: TAX STATUS

The Internal Revenue Service has determined and informed the Plan applicant by a letter dated April 29, 2014, that the Prototype Plan adopted by the Company in 2016 is designed in accordance with the applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or reduce an asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of March 1, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or reduction of an asset) or disclosure in the financial statements. The Plan is subject to routine audits by tax jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to December 31, 2019.

NOTE F: PLAN TERMINATION

On September 21, 2021, the Plan Sponsor announced it had signed an agreement to become part of Colliers Engineering & Design (CED). The closing of the transaction was effective November 1, 2021. Subsequent to the closing, all employees of the Plan Sponsor became part of CED. The Plan Sponsor and CED entered into an agreement to merge and transfer the Plan's assets to the Colliers Engineering & Design, Inc. 401(k) Savings & Retirement Plan. Effective January 1, 2022, the Plan was amended to cease all contributions into the Plan and the merger and transfer was expected to take place on February 28, 2022, or as soon as administratively feasible. As a result of the merger, the Plan has fully transferred all assets as of March 1, 2022, to the Colliers Engineering & Design, Inc. 401(k) Savings & Retirement Plan. The Bergmann Associates Retirement Savings Plan was liquidated and closed on March 1, 2022.

NOTE G: TRANSACTIONS WITH PARTIES-IN-INTEREST

In 2022 and 2021, certain plan investments are managed by Prudential Bank & Trust, F.S.B. and Prudential Retirement Insurance Annuity Company, the trustees, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions, which are exempt from prohibited transaction rules.

As described in Note B, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA.

NOTE H: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits – modified cash basis.
