INDEPENDENT AUDITORS' REPORT

To the Plan Administrator

De Pere, Wisconsin

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of De Pere Cabinet, Inc. Employees' Profit Sharing and Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 2, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period from January 1, 2022 to March 2, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of March 2, 2022 and December 31, 2021 and for the period from January 1, 2022 to March 2, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of De Pere Cabinet, Inc. Employees' Profit Sharing and Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Merger

As further discussed in Note 4 to the financial statements, the Plan participants merged into the Wellborn Forest Products, Inc. 401(k) Plan, effective January 1, 2022. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about De Pere Cabinet, Inc. Employees' Profit Sharing and Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTE 1 - PLAN DESCRIPTION

The following description of De Pere Cabinet, Inc. (Sponsor) Employees' Profit Sharing and Savings Plan (Plan) provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a contributory, defined contribution 401(k) plan available to substantially all qualifying employees of the Sponsor. The Plan originated on July 1, 1995. To be eligible to participate in the Plan and to receive the employer match, the employee must complete three months of service and be at least eighteen years of age. An eligible employee may enter the Plan on the first day of the first month after three months of service. Only those participants who are eligible employees of the Sponsor as of the last day of the Plan year will receive the employer match. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan administrator is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Participants could contribute up to the maximum amount allowed by law, as defined in the Plan, with the contributions and earnings thereon being nontaxable until withdrawn from the Plan. Participants could also contribute their after-tax annual compensation for Roth elective deferral purposes, subject to certain limitations, with the contributions and earnings thereon being nontaxable when withdrawn from the Plan. Participants who attained age fifty before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified plans. Such transfers from other qualified plans were reported as rollover contributions. The Sponsor was allowed to make a matching contribution to participant accounts in a discretionary amount. Participants directed the investment of their contributions into various options offered by the Plan.

Participants' Accounts

Each participant's account was credited with the participant's and the Sponsor's contributions and an allocation of net Plan earnings. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

Vesting

Participants were immediately vested in their voluntary contributions and any income or loss thereon. Participants became 100% vested in Sponsor contributions after six years of service. Amounts not vested at the time a covered employee ceased to participate in the Plan were forfeited.

Notes Receivable from Participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever was less. Participants could only have one outstanding loan at any point in time. The loans were secured by the balance in the participant's account and bore interest at the prime interest rate plus 1.00%. Principal and interest were paid through payroll deductions as indicated in the loan policy.

Payment of Benefits

Upon termination of service, due to death, disability, retirement or separation of service, a participant could elect to receive either a lump-sum distribution equal to the value of the participant's vested interest in his or her account or installment payments under various options. The Plan also permitted withdrawals from the Plan due to circumstances of financial hardship, in accordance with provisions specified in the Plan document. If a terminated participant's vested interest in his or her account was less than \$5,000 and he or she did not elect to receive a distribution from the Plan, benefits were paid in a single, lump-sum distribution as soon as administratively feasible.

Forfeitures

The nonvested portion of a terminated employee's account balance were forfeited and used to reduce Sponsor contributions or to pay administrative expenses. Unallocated forfeiture balances for the Plan periods ended March 2, 2022 and December 31, 2021 totaled \$0 and \$3,439, respectively.

Administrative Expenses

Certain expenses of maintaining the Plan were paid directly by the Sponsor and are excluded from these financial statements. Investment-related expenses were included in net appreciation or depreciation of fair value of investments. The Sponsor paid the administrative costs of the Plan associated with any professional services provided to the Plan and the cost of communications to the participants. Administrative expenses recorded in the Plan represented trustee fees, investment advisor fees and other recordkeeping fees paid directly from the Plan to the Plan's trustee and other third parties.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America. In preparing the financial statements, management evaluated subsequent events through January 13, 2023, the date the financial statements were available to be issued.

As required by accounting principles generally accepted in the United States of America, investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. One of the investment options in which participants could direct the investment of their accounts, the BNY Mellon Insight Stable Value Fund, held fully benefit-responsive investment contracts and fixed income securities, held in a common collective trust (CCT) fund. The statements of net assets available for benefits present the contract value of the investment in the CCT. The statement of changes in net assets available for benefits is prepared on a contract value basis.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit loss has been recorded as of March 2, 2022 and December 31, 2021. If a participant ceased to make loan repayments and the plan administrator deemed the participant loan to be in default, the participant loan balance was reduced and a benefit payment was recorded.

Concentration of Market Risk

As of December 31, 2021, approximately 22% of the Plan's net assets were invested in one mutual fund. The underlying value of the investments were dependent on the performance of the individual investment holdings and the market's evaluation of such performance. It was at least reasonably possible that changes in the fair value of the mutual funds and their investment holdings in the near term could have materially affected participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Income Recognition

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Realized gains and losses from security transactions were reported on the average cost method.

Fair Value

The established framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Fair value is the price the Plan would expect to receive to sell an asset or pay to transfer a liability in an orderly transaction with a market participant at the measurement date. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan had the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs which are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability had a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Refund of Excess Contributions

Amounts payable to participants for contributions in excess of amounts allowed by the IRS were recorded as a liability with a corresponding reduction in distributions.

De Minimis Distributions Payable

Amounts payable to participants for de minimis distributions not yet disbursed were recorded as a liability with a corresponding increase in distributions.

Payment of Benefits

Benefits were recorded when paid.

NOTE 3 - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustee, Johnson Bank, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments at fair value and notes receivable from participants, included in the statements of net assets available for benefits as of March 2, 2022 and December 31, 2021.
- Investment income, which includes net appreciation in fair value of investments, included in the statement of changes in net assets available for benefits for the period from January 1, 2022 to March 2, 2022.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information with the related information included in the financial statements and supplemental schedule.

NOTE 4 - PLAN TERMINATION DUE TO MERGER

Pursuant to the Plan amendment that went into effect on January 1, 2022, employees who were eligible for the De Pere Cabinet, Inc Employees' Profit Sharing and Savings Plan became immediately eligible for the Wellborn Forest Products, Inc. 401(k) Plan. The Plan's official termination date was March 2, 2022. The assets of the De Pere Cabinet, Inc Employees' Profit Sharing and Savings Plan were transferred to the Wellborn Forest Products, Inc. 401(k) Plan on January 4, 2022, February 2, 2022 and March 2, 2022.

NOTE 5 - RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate and market risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and such changes would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 - FAIR VALUES

The following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used during the year ended December 31, 2021.

- *Mutual funds*: Valued at the closing price reported on the active market on which the individual securities are traded.
- *Common Collective Trust*: Valued at the net asset value per share/unit reported at the close of every business day.

The preceding methods described could have produced a fair value calculation that would not be indicative of net realizable value or reflective of future fair values. Furthermore, although management believes its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date.

NOTE 7 - INCOME TAX STATUS

The Plan was a Johnson Bank volume submitter defined contribution plan. The Internal Revenue Service ruled, in a letter dated September 21, 2017, that the volume submitter plan developed by Johnson Bank, after which the Plan was modeled, qualified under the applicable sections of the Internal Revenue Code (IRC). Although the Plan was amended since receiving the advisory letter, the plan administrator and the Plan's tax counsel believe that the Plan was designed, and being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan was qualified and the related trust was tax-exempt.

Tax positions are recognized in the financial statements when it is more likely than not that the position will be sustained upon examination by the tax authorities.

The Sponsor has concluded, as of March 2, 2022 and December 31, 2021, the Plan had no significant uncertain tax positions or material amounts of unrecognized tax benefits that qualified for either recognition or disclosure in the financial statements for open tax years based on an assessment of many factors including experience and interpretations of tax laws.

NOTE 8 - RELATED PARTY TRANSACTIONS

Certain Plan investments, including mutual funds, were managed by Johnson Bank, the trustee of the Plan and, therefore, qualified as party-in-interest transactions.
