## **1. Description of the Plan**

The following description of the Powers Distributing Company, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan's summary plan description for a more complete description of the Plan's provisions.

### **General (including Plan Termination)**

The Plan was a defined contribution plan covering all non-union employees of Powers Distributing, Inc. (the Company) who had completed at least one year of service with the Company, as defined in the Plan, and were age 21 or older are eligible to participate. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan's sponsor was sold in December 2021. In connection with this, the Plan was terminated in December 2021. Upon termination of the Plan, the Employer had directed the trustee to pay all liabilities and expenses of the Plan. The liquidation of the Plan was ongoing during the period ended June 2, 2022, and all assets have been distributed to participants subject to the applicable requirements of ERISA and in accordance with the provisions of the Plan. Participants of the Plan were given the option of transferring their accounts to the new plan or taking a distribution. In connection with this, \$6,485,724 in plan assets were transferred to the new plan in January 2022. The Plan has filed the required termination notice with the Department of Labor (DOL) and also has provided all necessary disclosures to participants. As a result, the accompanying liquidation basis financial statements reflect all financial effects of the termination and resulting distribution of all Plan assets.

### **Contributions**

Each year, participants could have contributed up to 100% of pretax annual compensation, as defined in the Plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants could have designated all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could have also contributed amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Plan automatically increased the deferral rate to 4% in year 3, 5% in year 4 and 6% in year 5. Participants direct the investment of all contributions into various investment options offered by the Plan. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

The Company contributed 100% of the first 5% of Plan compensation that a participant contributes to the Plan (qualified safe harbor contribution) during 2021.

### **Participant Accounts**

Each participant's account was credited with the participant's salary reduction contributions, rollover contributions and the Company's matching contribution, as well an allocation of the Company's profit sharing contribution and the Plan's earnings (net of administrative expenses). Allocations were based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant was entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants were vested immediately in their contributions plus actual earnings thereon. Participants were vested in any discretionary employer profit sharing and matching contributions portion of their accounts based on a six year graded schedule as follows:

### Notes Receivable From Participants

Participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the vested balance in the participant's account and bear an interest rate ranging from 4.25% to 6.50%, which was commensurate with local prevailing rates. Principal and interest was paid ratably through weekly payroll deductions.

### Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant could receive a lump-sum distribution equal to the value of the participant's vested interest in their account. In addition, the Plan allowed for hardship distributions if certain criteria were met.

### Forfeited Accounts

At June 2, 2022 and December 31, 2021, forfeited non-vested accounts totaled \$0 and \$3,200, respectively. During 2022, \$3,200 of prior year forfeitures was reallocated to participants.

### Coronavirus Aid Relief and Economic Security Act

On March 27, 2020, the Coronavirus Aid Relief and Economic Security Act (CARES Act) was signed into law. This aid package was designed to help the economy from the effects of the coronavirus pandemic, several of the provisions of CARES Act affected employee benefit plans. The provisions of the CARES Act were optional. During 2020, the Plan opted into the following provisions of the CARES Act:

- Hardship distributions - Qualified Plan participants were permitted to take a coronavirus-related distribution of up to \$100,000 from the Plan without a 10% early withdrawal penalty. Eligible distributions were permitted to be taken until December 30, 2020. Distributions may be repaid within three years or a participant may elect these distributions to be included in taxable income on a pro rata basis over three years.

- Participant loans - Participants with loans outstanding were permitted to defer payment on the loans that were due during 2020 to after January 1, 2021.
- Participant loans - Participants may have borrowed up to \$100,000 during 2020 (an increase from \$50,000 previously permitted), these repayments were able to be delayed until 2021.
- Required minimum distributions (RMDs) - A temporary waiver of required minimum distributions rules permitted participants to suspend their RMDs for 2020 for participants that turned 70 1/2 in 2020 and 72 in 2020.

## **2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

As a result of the termination of the Plan described in Note 1, the accompanying financial statements of the Plan are presented on the liquidation basis of accounting.

### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the gains and losses on investments bought and sold as well as held during the year.

### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees were recorded as administrative expenses and are expensed when they were incurred. Interest income is recorded on the accrual basis. No allowance for credit losses is recorded as of December 31, 2021.

### **Expenses**

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### **Payment of Benefits**

Benefits are recorded when paid.

## **Subsequent Events**

The Plan has evaluated subsequent events for recognition or disclosure through December 9, 2022, the date the financial statements were available to be issued.

## **3. Fair Value of Financial Instruments**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2021 (there were no plan assets at June 2, 2022).

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The collective trust fund is valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### 4. Administration of Plan Assets

The Plan's assets were administered under a contract with John Hancock Trust Company LLC, the custodian of the Plan. The custodian invested funds received from contributions, investment sales, interest, and dividend income and made distribution payments to participants.

#### 5. Related-Party and Party in Interest Transactions

Certain of the Plan's investments were managed by the custodian, and therefore, these transactions qualified as party in interest transactions. Fees incurred by the Plan for the investment manager services are included in net appreciation in the fair value of the investment, as they were paid through revenue sharing, rather than a direct payment. Additionally, the Plan issued loans to participants, which were secured by the participants' account balances. These transactions qualified as party in interest transactions.

Certain administrative functions of the Plan were performed by officers or employees of the Company. No such officer or employee received compensation from the Plan.

### **6. Tax Status**

The IRS had determined and informed the Company by a letter dated September 1, 2014, that the Plan was designed in accordance with applicable sections of the IRC. The Plan administrator believed that the Plan was designed and was operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan was qualified.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **7. Risks and Uncertainties**

The Plan invested in various investment securities. Investment securities were exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

As of December 31, 2021, the Plan had investments of \$1,312,493 that were concentrated in two funds.

### **8. Information Certified by the Custodian**

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2022 and 2021. Accordingly, John Hancock Trust Company LLC, the custodian of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of June 2, 2022 and December 31, 2021 and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2021, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the the period January 1, 2022 to June 2, 2022 and the year ended December 31, 2021.
