#### **Note 1: Description of the Plan**

The following description of American Products, LLC 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the plan document and Summary Plan Description for a more complete description of the Plan's provisions, which are available from the plan administrator.

#### **General**

The Plan is a defined contribution plan sponsored by AmProd Holdings, LLC (Company) and its affiliated entities for the benefit of its employees who have at least one year of service and are age 18 or older. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Capital Bank and Trust Company is the custodian of the Plan.

#### **Termination of the Plan**

The Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. Effective May 20, 2022, the Board of Directors of the Plan Sponsor approved the termination of the Plan, and the Plan was amended to terminate the Plan. As a result, all participants became 100 percent vested in their accounts. The Plan shall make distributions to all participants pursuant to the applicable provisions of ERISA. All plan assets were liquidated before October 31, 2022.

#### **Sponsor Company Acquired**

Effective December 31, 2021, the plan sponsor, American Products, LLC, entered into an agreement to be acquired by KOCH Enterprises, Inc.

#### **Contributions**

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions up to the maximum allowed by the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Employee rollover contributions are also permitted. The Company makes safe harbor matching contributions equal to 100 percent of employees' salary deferral amounts not exceeding 3 percent of compensation, plus 50 percent of any deferrals between 3 percent and 5 percent of employees' compensation. Company profit-sharing contributions are discretionary as determined by the Company. No discretionary contributions were made in 2022 or 2021. Contributions are subject to certain Internal Revenue Code limitations.

#### **Participant Investment Account Options**

Investment account options available include various funds. Each participant has the option of directing his contributions into any of the separate investment accounts and may change the allocation daily. Eligible employees are automatically enrolled in the Plan with a 5 percent deferral rate, unless making an affirmative election otherwise or electing a different deferral percentage.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's contribution, and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Notes Receivable from Participants***

The plan document includes provisions authorizing loans from the Plan to active eligible participants. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50 percent of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on the prime rate as published by the *Wall Street Journal*.

***Vesting***

Participants are immediately vested in their voluntary contributions and the Company contributions plus earnings thereon.

***Payment of Benefits***

Upon termination of service, a participant's account balance will be distributed to them in a lump-sum distribution. Withdrawals other than for termination are permitted under circumstances provided by the Plan.

**Note 2: Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements for 2022 are prepared on the liquidation basis of accounting. The accompanying financial statements for 2021 are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. Common Collective Trusts are valued at the NAV of units of the common/collective trust fund. The NAV as provided by the fund, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

#### ***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

#### ***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

### **Note 3: Certification of the Plan Custodian**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Capital Bank and Trust Company, the custodian of the Plan, has certified the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2021.
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the period ended October 31, 2022 and the year ended December 31, 2021.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**Note 4: Fair Value Measurements**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

***Recurring Measurements***

**Investments**

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities include mutual funds and are valued at the net asset value (NAV) of shares held by the Plan at year-end. If quoted market prices are not available, then fair values are estimated by using pricing models, quoted prices of securities with similar characteristics, or discounted cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

The Plan paid \$4,760 and \$3,779 of record keeping fees to Capital Bank & Trust Company during 2022 and 2021, respectively. Additional fees were incurred by the Plan for investment advisory services during 2022 and 2021. The Company provides certain administrative services at no cost to the Plan.

**Note 7: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially adversely affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

The outbreak of the novel coronavirus COVID-19, which was declared a pandemic by the World Health Organization on March 11, 2020, has led to adverse impacts on the U.S. and global economies. Economic uncertainties have arisen, which have resulted in significant volatility in the investment markets and may continue to impact the value of plan assets. The duration of these uncertainties and the ultimate financial effects cannot be reasonably estimated at this time.

**Note 8: Plan Tax Status**

The Plan operates under a nonstandardized adoption agreement in connection with a prototype 401(k) profit-sharing plan and trust sponsored by American Funds Distributors Inc. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

**Note 9: Subsequent Events**

Subsequent events have been evaluated through January 11, 2023, which is the date the financial statements were available to be issued.
