SCOPE AND NATURE OF THE ERISA SECTION 103(a)(3)(C)

We have performed audits of the accompanying financial statements of Arnett Carbis Toothman LLP 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits in liquidation as of May 16, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits in liquidation for the period ended May 16, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Arnett Carbis Toothman LLP 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

## BASIS FOR OPINION

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## EMPHASIS OF MATTER - BASIS OF ACCOUNTING

As described in Note 1 to the financial statements, the Plan Sponsor of the Plan approved a plan of liquidation effective October 31, 2021, and management determined liquidation is imminent. As a result, the Plan has used the liquidation basis of accounting in the accompanying financial statements. Our opinion is not modified with respect to this matter.

## RESPONSIBILITIES OF MANAGEMENT FOR THE FINANCIAL STATEMENTS

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.



Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Note 1. Plan Description**

**Description of Plan:** The following is a brief description of the Arnett Carbis Toothman LLP 401(k) Profit Sharing Plan (the Plan) which provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:** Prior to termination, the Plan was a defined contribution 401(k) safe harbor. The Plan provided for salary deferral contributions, Roth contributions, and employer contributions under Section 401(k) of the Internal Revenue Code. Substantially all employees who attained the age of 21 and had completed 500 hours of service during the six month period following the date of hire were eligible to participate in the Plan. An eligible employee became a participant as of the first day of the first, fourth, seventh, or tenth month of the Plan year coinciding with the date the employee's eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

On September 16, 2021, the Plan Sponsor announced the Plan Sponsor combination into Baker Tilly US LLP effective November 1, 2021. Consequent to this combination, on September 20, 2021, the management of the Plan Sponsor commenced processes to terminate the Plan effective October 31, 2021. Effective with the termination of the Plan, all participants with an account balance remaining in the Plan became fully vested in all contribution sources, regardless of status or years of vested services. The Plan's termination also ended employee and employer contributions into the Plan and ended the issuance of new participant notes receivable from the Plan. Existing employees of the Plan Sponsor that became employees of Baker Tilly US LLP were eligible to participate in the 401(k) plan of Baker Tilly US LLP. All of the Plan's assets were distributed by May 16, 2022.

**Contributions:** Prior to termination of the Plan, each participant could elect to contribute in either pre-tax or Roth 401(k) deferrals up to the maximum allowed under the Internal Revenue Code for such plan year. Participants received an employer's contribution at a rate determined by the Plan Sponsor to be no less than 3% of the participant's compensation. The Plan Sponsor could also make a discretionary contribution allocated among participants employed by the Plan Sponsor on the last day of the plan year based on formulas defined within the Plan document. Rollover contributions from other qualified plans were permitted. Contributions to the Plan ceased effective October 31, 2021.

**Participant Investment Options:** Prior to the termination of the Plan, participant accounts were self-directed allowing each Plan participant the right to direct all contributions and earnings of their account among alternative investment funds provided under the Plan. Participants could transfer funds between investment options at any time.

**Participant Accounts:** Prior to the termination of the Plan, each participant's account was credited with the participant's elective contributions, employer contributions, an allocation of Plan earnings, and the participant's share of Plan expenses. The benefit to which a participant was entitled was the benefit that could be derived from the participant's account.

**Vesting Prior to Plan Termination:** Prior to the termination of the Plan, participants became immediately vested in their deferral contributions, rollovers, employer safe harbor and other qualified employer contributions as defined in the Plan Document, and actual earnings thereon which had been credited to their respective account. Discretionary employer contributions were vested in accordance with the vesting schedule prescribed by the Plan's governing document, however, as previously disclosed, effective with the termination of the Plan, all participants with account balances remaining in the Plan became fully vested in all contribution sources, regardless of status or years of vested services.

**Payment of Benefits:** Prior to the termination of the Plan, upon retirement (normal retirement age is 62, unless the participant was a participant of the former Arnett & Foster PLLC 401(k) Profit Sharing Plan and attained age 55 as of December 31, 2015), death, disability or other termination of employment, as defined in the Plan document, participants or their spouses and/or beneficiaries could elect to receive their account as a lump sum cash payment equal to the value of the participant's vested interest in his or

her account. Further, upon termination of employment, the participant could elect to transfer his or her account balances to another qualified plan or individual retirement account.

Prior to the termination of the Plan, the Plan allowed for hardship withdrawals for certain participant needs as defined in the Plan document from participant elective contributions and related earnings.

Prior to the termination of the Plan, the Plan also allowed for in-service distributions.

**Notes Receivable from Participants:** Prior to the termination of the Plan, participants could borrow from the Plan. These loans could be no less than \$1,000 and were to be secured by the balance in the participant's account and bear interest commensurate with prevailing rates. These loans were limited to the lesser of \$50,000 or 50% of the participant's vested account balance. Loan principal and interest payments were made in accordance with the note's amortization schedule. Any loan that remained unpaid after a participant ceased employment with the Plan Sponsor would automatically be treated as a distribution to the participant. The loans of participants that transferred their related participant accounts to the 401(k) plan of Baker Tilly US LLP also transferred their loan balances. After October 31, 2021, no new borrowings were permitted.

**Forfeited Accounts:** Plan forfeitures could be used to pay administrative expenses or used to reduce employer contributions. As of December 31, 2021, forfeited non-vested accounts totaled \$1,710. The forfeitures were used to reduce employer contributions for the year ended December 31, 2021.

**Note 2. Summary of Significant Accounting Policies:**

**Basis of Accounting:** The Plan's financial statements have been prepared using the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates that affect the amounts reported in the financial statements and accompanying informative disclosures. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition:** All investments reported in the Statement of Net Assets in Liquidation Available for Benefits as of December 31, 2021, are reported at liquidation value. For all investments fair value approximated the amount the Plan expected to collect upon liquidation.

Purchases and sales of securities were recorded on a settlement-date basis. Interest income and dividends were recorded on the liquidation basis, including amounts expected to be earned through the final distribution of Plan assets. Net depreciation includes the Plan's net gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants:** Loans to participants as of December 31, 2021, are reported as notes receivable from participants at the unpaid principal balance plus any accrued but unpaid interest. Fees related to the administration of notes receivable from participants have been charged directly to the participant's account and included in administrative fees when incurred. Delinquent participant loans have been reclassified as distributions based upon the terms of the plan document. No allowance for credit losses were recorded as of December 31, 2021.

**Payment of Benefits:** Benefit payments were recorded when paid.

**Administrative Expenses:** Expenses of maintaining the Plan could be paid by the Plan Sponsor or by the Plan.

**Subsequent Events:** The Plan has evaluated subsequent events through December 29, 2022, the date the financial statements were available to be issued.

**Note 3. Investment Information Certified by the Trustee**

The Plan Administrator elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under the ERISA for period from January 1, 2022, through May 16, 2022, and the year ended December 31, 2021. Accordingly, Alerus Financial N.A., the trustee of the Plan, has certified to the completeness and accuracy of all investments including notes receivable from participants reported in the accompanying statements of net assets in liquidation available for benefits as of May 16, 2022, and December 31, 2021, and the related investment activity reported in the statement of changes in net assets in liquidation available for benefits for the period from January 1, 2022, through May 16, 2022.

**Note 4. Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

---

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

---

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

---

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

---

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value as of December 31, 2021.

*Mutual Funds:* Shares of mutual funds are valued at net asset value of shares at market exchange price held at valuation date. Interest and dividend income is recorded when received.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5. Income Tax Status**

The underlying standardized prototype plan adopted effective January 1, 2016, received an opinion letter from the Internal Revenue Service (IRS) dated January 27, 2015, stating that the form of the Plan is qualified under Section 401 of the Internal Revenue Code and, therefore, the related trust was tax exempt. In accordance with Revenue Procedure 2002-6 and Announcement 2001-77, the Plan's management determined that it has been eligible to, and has chosen to, rely on the current IRS prototype plan opinion letter. Plan management operated the Plan in conformity with the Internal Revenue Code to maintain the Plan's qualification.

Accounting principles generally accepted in the United States of America require plan management to evaluate positions taken by the plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to income tax examinations by the U.S. Federal, state, or local tax authorities.

**Note 6. Parties-in-interest and Related Party Transactions**

Parties-in-interest are defined under United States Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer and certain others. The Plan Sponsor contracts with Alerus Financial N.A., and Charles Schwab Bank to administer the Plan's assets, provide custodial services and to administer participant account records. During the period from January 1, 2022, through May 16, 2022, fees for these services amounted to \$34,559.

Certain administrative functions have been performed by employees of the Plan Sponsor and are at no cost to the Plan.
