We have performed audits of the accompanying financial statements of Reeb Millwork Corporation 401(k) Plan (“plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Emphasis of Matter – Termination of Plan

As further discussed in Note 6 to the financial statements, Reeb Millwork Corporation (company) approved to terminate the plan on October 3, 2021 and the company commenced liquidation thereafter. As a result, the plan's financial statements are presented using the liquidation basis of accounting. Our opinion is not modified with respect to that matter.

NOTE 1 Description of Plan

The following description of the Reeb Millwork Corporation 401(k) Plan (plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

General

The plan is a defined contribution plan covering substantially all employees of Reeb Millwork Corporation and their affiliated companies (company) who have completed three months of service and are over the age of 18. The plan is subject to the provisions of ERISA.

Contributions

Each year, participants may contribute up to 100 percent of pre-tax eligible compensation, subject to certain limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The company may provide a discretionary matching contribution as determined by the company's Board of Directors. For the year ended December 31, 2021, the company provided matching contributions of twenty-five percent of the first six percent of the employee's base compensation that a participant contributes to the plan. Employer discretionary matching contributions were \$25,832 and \$727,513 for the period ended April 7, 2022 and the year ended December 31, 2021, respectively.

Participants direct the investment of their contributions into various mutual funds and a common collective trust offered by the plan.

Automatic Enrollment

Upon hire, the plan enrolls eligible participants for salary deferrals under its automatic enrollment feature. Employees who are automatically enrolled have 3 percent of eligible compensation contributed to the plan as a pre-tax contribution. Employees who are automatically enrolled have the option of changing their deferrals or electing out of participation at their request. This automatic enrollment will occur on the first plan entry date after meeting the plan's eligibility requirements.

Pre-tax contributions will increase automatically for these participants (unless they elect otherwise). The remaining participants, who were not automatically enrolled, also have the option to automatically increase their pre-tax contributions. In either case, pre-tax contributions will increase by 1 percent of compensation during the month of January each year until the pre-tax contribution percentage equals 10 percent of compensation. Unless the participant elects otherwise these contributions will be invested in one of the T. Rowe Price Target Date Funds, based on the year in which the participant turns 65.

NOTE 1 **Description of Plan (Continued)**

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the company's contribution and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the company's discretionary matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100 percent vested after five years of credited service.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account. Interest rates are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

On termination of service, a participant or designated beneficiary, as applicable, may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, periodic installments subject to minimum distribution rules or an annual annuity purchased from an insurance company.

For married participants, the normal form of payment is a joint and 50 percent survivor annuity. For unmarried participants, the normal form of payment is a single life annuity.

Forfeited Accounts

At April 7, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$0 and \$190,553, respectively. Any remaining forfeited accounts have been distributed to current participants.

NOTE 2 **Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the plan are prepared on the liquidation basis of accounting.

NOTE 2 **Summary of Significant Accounting Policies (Continued)**

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of April 7, 2022 and December 31, 2021. Delinquent participant loans are recorded as distributions on the basis of the terms of the plan agreement.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. There were no amounts required to be distributed at April 7, 2022.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the plan are paid directly by the company and are excluded from the financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Subsequent Events

The plan has evaluated events and transactions for potential recognition or disclosure in the financial statements through October 27, 2022, the date the financial statements were available to be issued. No events or transactions occurred subsequent to this date that would require recognition or disclosure in the financial statements.

NOTE 3 **Information Prepared and Certified by Trustee**

As permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, all investment information in the accompanying financial statements was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by State Street Bank and Trust Company, the trustee, and was not subject to audit.

NOTE 4 **Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows.

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There has been no change in the methodologies used at April 7, 2022 and December 31, 2021.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

Common collective trust: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business matter.

NOTE 5 Related-Party Transactions

State Street Bank and Trust Company (State Street) is the trustee and custodian as defined by the plan. Transactions with State Street qualify as party-in-interest transactions. Fees paid by the plan for the investment management services and/or transactional items amounted to \$42,229 and \$152,369 for the period ended April 7, 2022 and the year ended December 31, 2021, respectively.

NOTE 6 Plan Termination

On October 3, 2021, the company approved to terminate and liquidate the plan. The net assets of the plan were distributed to participants in accordance with the plan document and ERISA rules. Participants could elect a lump-sum distribution, to rollover balances to a qualified plan or a direct rollover into an individual retirement account. The plan's assets have been liquidated as of April 7, 2022.

NOTE 7 Tax Status

The plan has adopted a standardized prototype plan as designed by Transamerica Retirement Solutions Corporation. The prototype plan received a determination letter from the Internal Revenue Service on March 31, 2014, which stated that the plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the plan has been amended since receiving the determination letter, the plan administrator believes that the plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believes that the plan is qualified and the related trust is tax-exempt.

NOTE 8 Risks and Uncertainties

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
